The Central Valley Regional Water Quality Control Board (Central Valley Water Board) is releasing for public review and comment a tentative NPDES Permit (Order) for the Mountain House Community Services District (Discharger) located in Mountain House, California.

NOTICE IS HEREBY GIVEN that the Central Valley Water Board will receive written comments on the tentative Order no later than **1 June 2023**, in accordance with this notice, and will consider adopting the tentative Order after a public hearing at its scheduled meeting on **22/23 June 2023**.

NOTICE IS HEREBY ADDITIONALLY GIVEN that, if the tentative Order is adopted by the Central Valley Water Board, the State Water Resources Control Board (State Water Board) will accept written comments on the proposed concurrence with the Central Valley Water Board's exception to the *Water Quality Control Plan for Control of Temperature in the Coastal and Interstate Water and Enclosed Bays and Estuaries of California* (Thermal Plan) for the Discharger. The State Water Board will accept written comments between **23 June and 24 July 2023**, in accordance with this notice, and will consider concurrence at its meeting on **17 October 2023**.

Background

1. Facility

The Mountain House Community Services District (Discharger) is the owner and operator of the Wastewater Treatment Plant (Facility), located at 17103 W. Bethany Road, Mountain House, California, 95391. The Facility provides sewerage service for the community of Mountain House and serves a population of approximately 21,750. The Facility provides tertiary treatment and ultraviolet light disinfection for up to 3.0 million gallons per day (MGD), with plans to expand the capacity up to 5.4 MGD to accommodate for planned growth within the service area. Construction is currently underway for the Facility expansion. Disinfected tertiary treated wastewater from the Facility is discharged to Old River, a water of the United States within the legal boundary of the Sacramento-San Joaquin Delta.

2. NPDES Permit

Discharges from the Facility are currently regulated by Waste Discharge Requirements Order R5-2017-0119, issued by the Central Valley Water Board on 8 December 2017. The NPDES Permit expired on 31 January 2023 and the Discharger submitted a Report of Waste Discharge for permit renewal on 21 January 2022. Per federal regulations, the NPDES Permit has been administratively extended and continues in effect until the permit renewal.

An Order is proposed to renew the NPDES permit. The tentative Order includes new or updated effluent limitations for ammonia, chlorodibromomethane, and dichlorobromomethane.

The tentative Order proposes effluent limitations and other requirements to implement the State Policy for Water Quality Control: Toxicity Provisions (as amended 5 October 2021) ("Toxicity Provisions"). The Toxicity Provisions will take effect upon approval by U.S. EPA. If U.S. EPA does not approve the Toxicity Provisions before the public hearing, Central Valley Water Board staff will propose revisions to the tentative Order to remove these requirements and include monitoring requirements, and, as appropriate, effluent or receiving water limitations for chronic and acute toxicity based on the Basin Plan's narrative toxicity objective and the Policy for Implementation of Toxics Standards for Inland Surface Waters, Enclosed Bays, and Estuaries of California (2005).

Additionally, the tentative Order proposes an exception to temperature water quality objectives contained in the Thermal Plan and alternative temperature effluent limitations. State Water Board concurrence with the exception is needed before the exception and alternative less stringent limitations would go into effect. The State Water Board will be separately accepting comments on the proposed concurrence, following the Central Valley Water Board's consideration of the tentative Order. Details on the State Water Board public meeting and opportunity for public comment are below.

2. Nature and Purpose of Public Hearing

At the hearing, the Central Valley Water Board will hear testimony and oral comments regarding the tentative Order. This proceeding will be a formal adjudicatory proceeding. The [procedures governing Central Valley Water Board adjudicatory hearings](#) (http://www.waterboards.ca.gov/laws_regulations/) may be found at California Code of Regulations, title 23, section 648 et seq. and are available upon request.

3. Prehearing Submission of Written Comments and Evidence

The **Discharger** is a party to this proceeding. As a party, the Discharger must submit written evidence or comments, if any, for the Board to consider no later than 5:00 p.m. on **1 June 2023** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov.

Interested persons include any non-party that is interested in the outcome of the hearing. Interested persons wishing to comment, in writing, on the tentative Order shall submit comments no later than 5:00 p.m. on **1 June 2023** to the Central Valley Water Board email at RB5S-NPDES-Comments@waterboards.ca.gov.

Pursuant to California Code of Regulations, title 23, section 648.4, the Board Chair may refuse to admit written evidence or comments that are not submitted in accordance with this Notice and shall refuse to do so when there is a showing of prejudice to the Discharger or the Board. Excluded material will not be considered by the Board.

4. Visual Presentations

5. Hearing Procedure and Time Limits

The hearing on the tentative Order will be conducted in the general order listed under California Code of Regulations, title 23, section 648.5, except that the Board Chair may modify the order for good cause.

The **Discharger** will be advised in advance of the hearing of the total amount of time allocated for its presentation and closing statement. The Discharger is invited to contact staff in advance of the hearing to discuss how much time it believes is necessary.

Interested persons may speak at the hearing and are expected to orally summarize their written submittals, if any. Each interested person will have 3 minutes to present oral comments. Additional time may be provided, upon request, at the discretion of the Board Chair.
