NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will hold a public webinar training session on how to complete the California Water and Wastewater Arrearage Payment Program Survey which will collect information on drinking water residential and commercial arrearages, as well as revenue loss during the COVID-19 pandemic. This survey will help the State Water Board determine Program eligibilities, application requirement, and the allocation of funds for community water systems. A quorum of State Water Board members may be present; however, no action will be taken.

BACKGROUND

The State Water Board is developing a program to distribute \$1 billion of relief to reduce customer water bills as a result of the COVID-19 pandemic.¹ This funding covers water debt from residential and commercial customers accrued between March 4, 2020 and June 15, 2021. It may also cover revenue loss. Legislation requires the State Water Board to survey water systems for outstanding debt and adopt program guidelines.

California Water and Wastewater Arrearage Payment Program Survey Webinar

The State Water Board will provide background information on the California Water and Wastewater Arrearage Payment Program. The State Water Board will be opening a survey for community water systems in early August to inform the funding allocation and eligibilities for the California Water and Wastewater Arrearage Payment Program. The webinar will provide an overview of the survey for all community water systems that are both interested and not interested in participating in the Program.

Community water systems will use a special link on the Electronic Annual Report (EAR) portal to complete this survey. When released, systems will have 30 days to complete the survey. Community water systems that have experienced COVID-19 related financial impacts for which they would like to request funding allocation, should begin preparing the following data for any billing period that includes the dates March 4, 2020 through June 15, 2021:

- For community water systems that charge customers for water:
 - Residential arrearages: The number of accounts and total accrued debt.
 You will also be asked to identify the number of accounts and total accrued debt with \$600 in debt or more.
 - Commercial arrearages: The number of accounts and total accrued debt.
 You will also be asked to identify the number of accounts and total accrued debt with \$600 in debt or more.
- Revenue loss:
 - 2019 total revenues; and 2019 total expenses for maintaining water system.
 - Revenue loss that has occurred during the COVID-19 pandemic (within your billing frequency that includes March 4, 2020 through June 15, 2021).

PROCEDURAL MATTERS

Due to ongoing circumstances related to the COVID-19 emergency, all public participation will be remote via an online hosted platform. Questions, comments, and discussion items will be collected via the webinar.
