BACKGROUND

The State Water Board is implementing the Safe and Affordable Funding for Equity and Resilience (SAFER) Drinking Water Program with a set of tools, funding sources, and regulatory authorities designed to ensure that the approximately one million Californians who currently lack safe drinking water receive safe and affordable drinking water as soon as possible.

The SAFER Program is responsible for conducting an annual Needs Assessment, which consists of three components: (1) Affordability Assessment, (2) Risk Assessment, and (3) Cost Assessment. Results of the Needs Assessment are used to inform the prioritization of projects in the annual Fund Expenditure Plan for the Safe and Affordable Drinking Water Fund.

The State Water Board's Needs Analysis Unit in the Division of Drinking Water lead the implementation of the Needs Assessment in coordination with the Division of Water Quality (DWQ) and Division of Financial Assistance (DFA). The University of California, Los Angeles (UCLA) was contracted (agreement term: 09.01.2019 through 03.31.2021) to support the initial development of Needs Assessment methodologies for the Risk Assessment and Cost Assessment.

2021 Risk Assessment and Affordability Assessment: Navigating the Results The focus of this webinar is to provide an opportunity for the public to ask questions about the results and the underlying data associated with the Risk Assessment and Affordability Assessment.

Risk Assessment Results Spreadsheet: The Risk Assessment results spreadsheet for public water systems identifies systems at risk or potentially at risk of failing to meet one or more key Human Right to Water goals: (1) providing safe drinking water; (2) accessible drinking water; (3) affordable drinking water; and/or (4) maintaining a sustainable water system. The results contain multi-faceted examination across four risk indicator categories: Water Quality, Accessibility, Affordability; and TMF (technical, managerial, and financial) Capacity.

Affordability Assessment Results: The Affordability Assessment results spreadsheet identifies disadvantaged community water systems, that have instituted customer charges that exceed the "Affordability Threshold" established by the State Water Board in order to provide drinking water that meets State and federal standards. For the 2021 Affordability Assessment, the State Water Board utilized three affordability indicators and corresponding thresholds to identify water systems that may be struggling with affordability challenges. The affordability indicators used in the Assessment include: Percent Median Household Income; Extreme Water Bill; and Percent Shut-Offs for Non-Payment.

Aquifer Risk Map: The Aquifer Risk Map was developed to fulfill requirements of Senate Bill (SB 200, Monning, 2019), and is a component of California's Safe and Affordable Fund for Equity and Resilience (SAFER) Program. The Aquifer Risk Map is intended to help prioritize areas where domestic wells and state small water systems may be accessing groundwater that does not meet primary drinking water standards (maximum contaminant level or MCL). In accordance with SB 200, the Aquifer Risk Map is available to the public and is to be updated annually starting January 1, 2021.
