### **NOTICE OF PUBLIC WORKSHOP REGARDING EMERGENCY REGULATION EFFORTS IN THE SCOTT RIVER AND SHASTA RIVER WATERSHEDS**

State Water Resources Control Board (State Water Board) staff will hold a workshop to facilitate the exchange of information and foster greater understanding on specific topics that can be used to inform the State Water Board's adoption of an emergency regulation for the Scott River and Shasta River watersheds.

During the workshop, State Water Board staff will provide an opportunity to discuss information on specific elements of the emergency regulation that the State Water Board adopted for the Scott River and Shasta River in 2021 and 2022. Parties are being invited to present information and answer questions on the following topics: baseline minimum flows for fisheries, the state of the fisheries in these watersheds, local cooperative solutions, and data.

#### **WORKSHOP DETAILS**

This workshop will focus on technical items related to the recently adopted emergency regulation for the Scott River and Shasta River watershed: minimum flows, the state of the fisheries, data, and local cooperative solutions. The input staff receive will help to inform the timing and content of a future emergency regulation. This workshop will not cover legal authorities associated with the emergency regulation. This event is being structured as a staff workshop, and while a quorum of the State Water Board may be present, no State Water Board action will be taken. Details of the workshop are as follows:

## **BACKGROUND**

The Scott River and Shasta River are important tributaries to the Klamath River, the second largest river in California. These rivers are crucial sources of water for Siskiyou County and have immense economic, ecological, and cultural importance. The Scott River and Shasta River watersheds provide water for agriculture, domestic users, the environment, fire protection, municipalities, Tribal Nations, and recreation. In 2021 and 2022, the State Water Board adopted an emergency regulation establishing minimum flows for the protection of the state- and federally-listed threatened coho salmon, fall-run Chinook salmon, and steelhead. The regulation includes other provisions, including exceptions for diversions for minimum human health and safety and livestock needs, and information order authority. The regulation expired on August 1, 2023 and the Board is initiating a process to again adopt an emergency regulation establishing minimum flows and similar provisions for the Scott River and Shasta River watersheds.
