LWA has historically performed dredging every three years or so, removing an average of 20,000 to 50,000 cubic yards of sediment each time the lake has been dredged. The greatest amount removed was 56,700 cubic yards in 1997. The exact amount of material removed is dependent on the size of preceding winter storms and the number of years between dredging operations.
