Acting Chair Stahl called the meeting to order at 9:16 a.m.

Acting Chair Stahl explained the process for participation in the virtual meeting, noting that for those who only want to listen or watch the meeting, the Board's customary webcast was available, and that the Board has Spanish translation services available through the Zoom platform for those who want to listen or participate in the meeting in Spanish. He provided instructions on how to join the Zoom meeting for those wishing to provide comments on an agenda item, and he announced that the meeting was being recorded.

Board Member Camacho

On June 17, 2022, she received an email from Ray Tahir regarding the Dominguez Channel odor matter. The email subject was titled, "Dominguez Channel odor was not caused by the warehouse fire in Carson"; there was a letter attached. Due to the subject being an impending prosecutorial matter, Board Member Camacho did not read the attached letter or email and forwarded them to Executive Officer Purdy.

Board Member Méndez:

He received the same email and letter as Board Member Camacho. He did not read the contents and forwarded them to Executive Officer Purdy.

Board Member Nahai:

He received the same email and letter as Board Member Camacho and forwarded them to Executive Officer Purdy.

Board Member Muñoz:

No ex parte communications reported.

Acting Chair Stahl:

On June 17, 2022, he received the same email and letter as the other Board Members and forwarded them to Executive Officer Purdy.

He also received an email from Maureen McGuire regarding Item 14 with two letters from the Ventura County Board of Supervisors, both of which he forwarded to Executive Officer Purdy.

Executive Officer Purdy confirmed that the email and letters were ex parte communications given that the Board's consideration of the Waste Discharge Requirements (WDRs) for Discharges from Irrigated Agricultural Lands is a pending matter. Because the WDRs are general WDRs, ex parte communications are not prohibited at this time but there are disclosure rules that must be followed for pending general WDRs.

Attorney Sophie Froelich further explained that beginning two weeks prior a scheduled adoption hearing for general WDRs, such as the Agricultural WDRs, exparte communications are prohibited.

Board Member Camacho reported on June 23, 2022, she attended a tour organized by the Ventura County Farm Bureau of two farms in the Oxnard Plain and a citrus ranch in Ojai. Ventura County Farm Bureau CEO Maureen McGuire and Los Angeles Water Board staff were in attendance.

Acting Chair Stahl reported on May 20, 2022, he participated in the Water Boards' Chairs' meeting virtually; he noted that Executive Officer Purdy attended in person.

On June 2, 2022, he attended a DTSC public meeting on the Santa Susana Field Laboratory, at which DTSC presented its Settlement Agreement with The Boeing Company to the public.

He also attended monthly Chairs' meetings on June 6 and July 11, 2022. The July

11, 2022, meeting included a presentation on recent advances in the Water Boards' racial equity work.

He also attended the Santa Monica Bay Restoration Commission Governing Board meeting. Notable presentations were made on the current funding round of the LA County Safe Clean Water Program and the Las Virgenes-Triunfo Pure Water indirect potable reuse project.

He also participated in the Measure W Regional Oversight Committee on June 16, 2022, as a non-voting member.

The EO provided updates on: 1) the Smith Service Station in Long Beach, a truck fuel refueling facility where groundwater contamination has migrated off-site, 2) the Garfield Express project in the City of Lynwood, where the Board has been overseeing the remediation of a site of a former gasoline service station and dry cleaner, and 3) the ongoing work to develop a statewide racial equity action plan per the resolution adopted by the State Water Board in Fall 2021.
