4. **Update on Status of Implementing the North Coast Dairy Program General Waste Discharge Requirements Order No. R1-2012-0002 and Conditional Waiver Order No. R1-2012-0003.** Cherie Blatt, Water Resources Control Engineer, Southern Nonpoint Source & Forestry Unit, gave an overview of the Dairy Program's enrollment and reporting requirements, water quality monitoring by counties, enforcement actions, and a summary of the program with dairy enrollments, education and reporting, water quality data, inspections, water quality improvements and concerns, along with the next steps of continued staff inspections, group surface monitoring, groundwater monitoring, the opening of two new facilities and the closing of six facilities, and potential Waiver fees, The Waivers will expire in January, 2017.

5. **Workshop on Draft Order No. R1-2015-0023 General Waiver of Waste Discharge Requirements (Waiver) and Initial Study for the Cannabis Discharge Regulatory Program.** Diana Henriouille, Senior Water Resources Control Engineer, Compliance Assurance Unit, introduced the Cannabis team of Water Resource Control Engineers, Kason Grady and Justin Smith; Connor McIntee, Environmental Scientist, and Derek Magnuson, Engineering Geologist, and the support staff of Stormer Feiler, Environmental Scientist, Compliance Assurance Unit; Adona White, Water Resource Control Engineer, Planning Unit; and Samantha Olson, Senior Staff Counsel, State Water Resources Control Board, Office of Chief Counsel. Diana Henriouille then outlined the joint State and Regional Water Boards and California Department of Fish and Wildlife statewide strategy of enforcement, regulatory program development and implementation, education and outreach, and interagency coordination, along with an overview of the applicability, conditions/management measures, multiple tiers, implementation, the accompanying documents for review of the Initial Study/Mitigated Negative Declaration, Notice of Intent form and a list of Best Management Practices and the next steps of the draft Order before adoption at the August 12 & 13, 2015 Board meeting.
