NOTICE OF CANCELATION OF HEARING

Bloomingcamp Water System (System No. 5000435)

TO ALL PARTIES:

On August 17, 2022, the Deputy Director for the State Water Resources Control Board (State Water Board or Board) Division of Drinking Water (Division) issued a Notice of Intent to Revoke Domestic Water Supply Permit No. 2018-03-017, issued to Bloomingcamp Water System, System No. 5000435 (Bloomingcamp Water System, Bloomingcamp). On September 20, 2022, Bloomingcamp Water System requested a hearing to contest the proposed revocation of its domestic water supply permit.

On October 24, 2022, the State Water Board's Executive Director assigned the proposed revocation of Bloomingcamp's Public Water System Permit No. 2018-03-017 to the Administrative Hearings Office (AHO) for a hearing and preparation of a proposed order.

On December 30, 2022, the AHO issued a Notice of Public Hearing, which set a hearing in the matter for March 3, 2023. The AHO conducted a pre-hearing conference on January 26, 2023. On February 17, 2023, the AHO postponed the hearing until a later date. On March 14, 2023, the AHO issued an amended hearing notice, which set the hearing for April 19, 2023, starting at 9:00 a.m.

On April 18, 2023, Heather Jidkov, an attorney with the Board's Office of Enforcement, advised the AHO by e-mail that the Division's Prosecution Team and Bloomingcamp Water System had reached a settlement agreement that addressed the August 17, 2022, Notice of Intent to Revoke Domestic Water Supply Permit No. 2018-03-017. The e-mail from Ms. Jidkov indicated that under the terms of the signed settlement agreement, the Division's Prosecution Team and Bloomingcamp Water System jointly requested that the AHO cancel the hearing in this matter.

Based on the representation from Ms. Jidkov that the Division's Prosecution Team and Bloomingcamp Water System have reached a settlement agreement and jointly request cancelation of the hearing, the AHO cancels the hearing in this matter that was scheduled for April 19, 2023, at 9:00 a.m.
