**NOTICE OF OPPORTUNITY FOR PUBLIC COMMENT,
PUBLIC HEARING, AND CONSIDERATION OF ADOPTION**

**AMENDMENT TO THE
WATER QUALITY CONTROL POLICY
ON THE USE OF COASTAL AND ESTUARINE WATERS
FOR POWER PLANT COOLING**

**TO EXTEND THE COMPLIANCE SCHEDULE
FOR THE REDONDO BEACH GENERATING STATION**

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will receive public comments on the Draft Amendment to the Water Quality Control Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling to Extend the Compliance Schedule for the Redondo Beach Generating Station (OTC Policy Amendment) and Draft Staff Report. The amendment to the Water Quality Control Policy on the Use of Coastal and Estuarine Waters for Power Plant Cooling (Once-Through Cooling or OTC Policy) would extend the compliance date for Redondo Beach Generating Station Units 5, 6, and 8 (Redondo Beach) for two years through December 31, 2023, to address system-wide grid reliability concerns.

NOTICE IS ADDITIONALLY HEREBY GIVEN that the State Water Board will hold a public hearing to receive oral public input and comments on the Proposed OTC Policy Amendment and Proposed Staff Report, and following the public hearing, the State Water Board will consider adoption of the OTC Policy Amendment and Staff Report. BACKGROUND

The State Water Board adopted the OTC Policy on May 4, 2010 (effective date October 1, 2010), as [Resolution No. 2010-0020](#) establishing technology-based standards to implement federal Clean Water Act section 316(b), which requires that the location, design, construction, and capacity of cooling water intake structures reflect the best technology available for minimizing adverse environmental impacts. The OTC Policy includes compliance dates for power plants using once-through cooling technology with orderly retirements and replacement of capacity aimed at maintaining local and system-wide electrical grid reliability in the State of California. Of the nineteen power plants originally covered by the OTC Policy, eleven have either retired, repowered, or have come into final compliance.

The joint-agency Statewide Advisory Committee on Cooling Water Intake Structures (SACCWIS) was created to advise the State Water Board on the implementation of the OTC Policy, ensuring compliance schedules take into account the reliability of California's electricity supply, including local area reliability, statewide grid reliability, and permitting constraints.

Recent events have resulted in concern for system-wide grid reliability in the summers of 2022 and 2023. Chiefly, a prolonged and extreme August 2020 heatwave caused a series of events that triggered rolling blackouts. California energy agencies conducted a system-wide analysis, or stack analysis, to compare capacity of all existing energy resources and resources expected to be online in 2022 to forecasted demand under similar conditions as those experienced during the August 2020 blackouts. The stack analysis demonstrated that energy supply is insufficient to meet projected demand in summer 2022. Additionally, the energy agencies' analysis pointed to several uncertainties in energy supply and demand in summer 2023. Redondo Beach Units 5, 6, and 8 were identified as resources available to partially mitigate the projected energy shortfall and support grid reliability.

On March 26, 2021, the SACCWIS approved the [2021 Report of the SACCWIS](#), which includes alternatives and a recommendation to the State Water Board to extend the OTC Policy compliance date for Redondo Beach for two years through December 31, 2023.

PROCEDURAL MATTERS

At the October 19, 2021 public hearing and consideration of adoption meeting, there will be no sworn testimony or cross-examination of participants. However, the State Water Board and its staff may ask clarifying questions. At the hearing, participants will be given an opportunity to provide oral comments. Participants will also be given an opportunity to summarize and supplement their written materials with oral presentations. Documentary or written evidence (other than a written version of oral comments) will not be accepted into the administrative record at the hearing or thereafter. To ensure a productive and efficient hearing in which all participants have an opportunity to participate, oral comments may be time-limited. 
