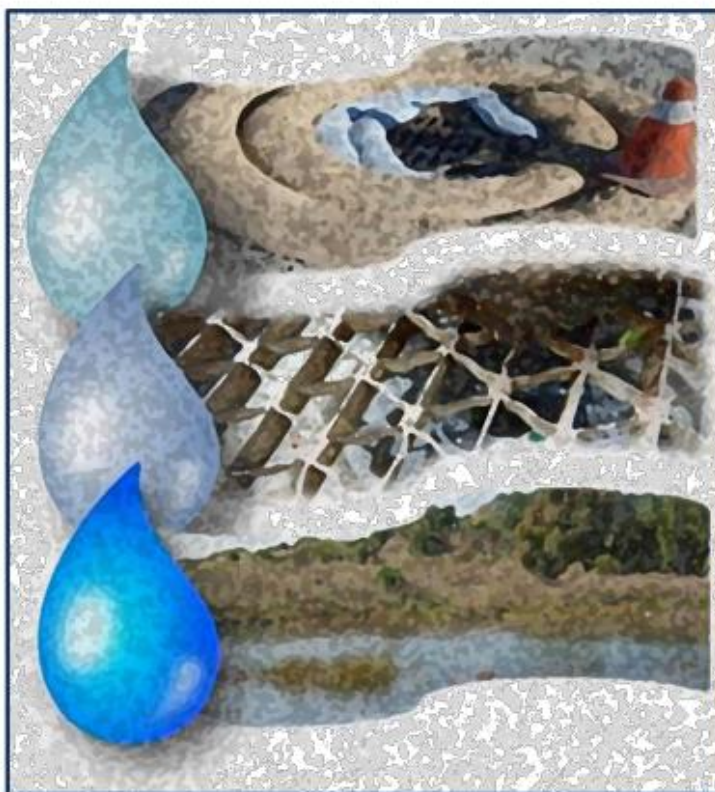

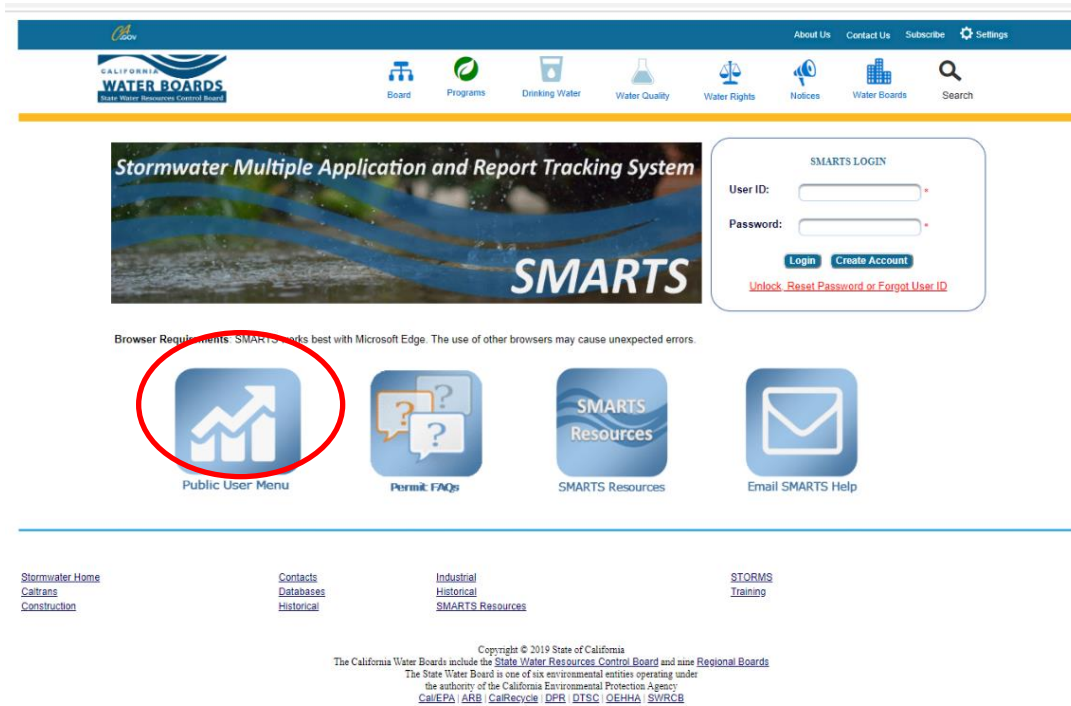
## Caltrans MS4 Permit Program Reports



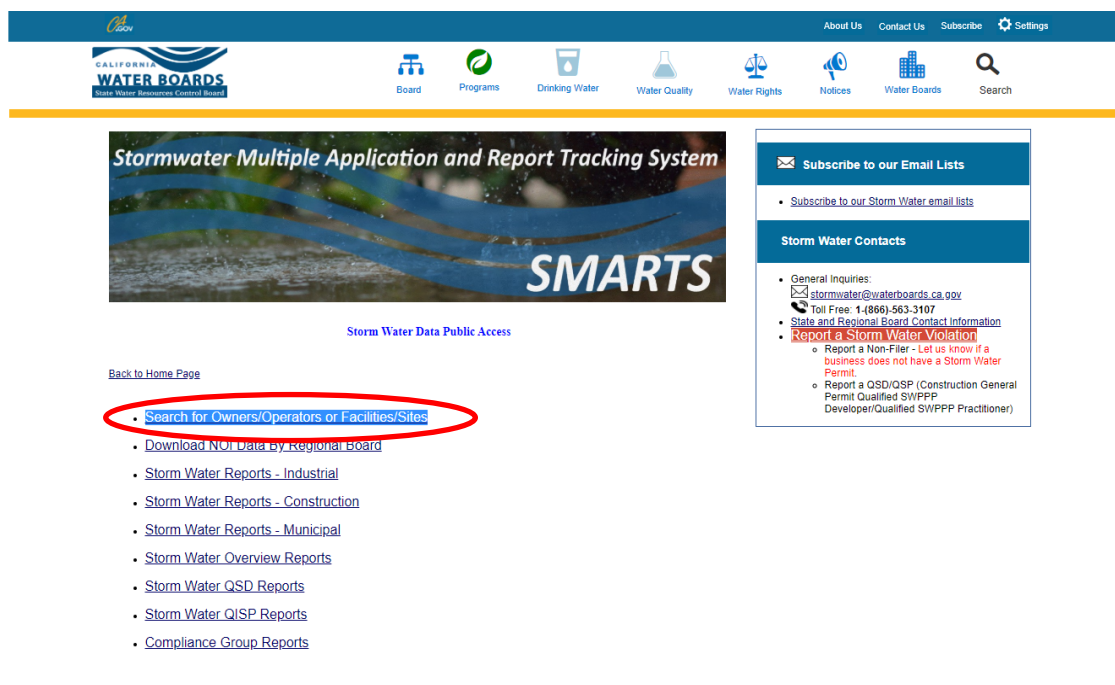

This guide has been prepared for accessing Caltrans MS4 Permit related documents in the Storm Water Multiple Application and Report Tracking System (SMARTS) database. Please use the Microsoft Edge browser to logon to [SMARTS](https://smarts.waterboards.ca.gov) (<https://smarts.waterboards.ca.gov>) and perform the following steps:

1. Select the **‘Public User Menu’**



2. Select **‘Search for Owners/Operators or Facilities/Sites’**



3. At the **'Notice of Intent Search Criteria'** page go to:
  - a. **'Application Type'**;
  - b. Select **'Caltrans MS4'** in the dropdown menu; and
  - c. Click **'Search'**.
