Dear Mr. Ekdahl,

In compliance with Condition 4 of the February 15, 2022 Order on Petitions for Reconsideration of the June 1, 2021 Order Conditionally Approving a Petition for Temporary Urgency Changes (Reconsideration Order), Order WR 2022-0095, the Department of Water Resources (DWR) hereby submits the attached electronic spreadsheet, which includes a written accounting of monthly State Water Project (SWP) contract deliveries that occurred during Water Year 2021.

Table 1 of the spreadsheet presents the total deliveries DWR made to Feather River Agencies' service areas (without transfer water) and transfer water from Feather River Agencies to SWP contractor buyers. Table 2 of the spreadsheet presents the total deliveries from DWR to SWP contractors that purchased transfer water from Feather River Agencies. Deliveries of water to Feather River Agencies was identified based on publicly available information and DWR does not assert any opinion on the underlying water rights through the submission of this spreadsheet. In addition, consistent with the statements by Water Board members and staff during the February 15, 2022 meeting adopting the Reconsideration Order, the spreadsheet includes information about SWP water supplies and not about diversions outside the SWP purview, for which DWR does not maintain data.

DWR looks forward to continued collaboration with the Water Board during this challenging hydrologic period. If you have any questions about the attached spreadsheet, please let me know. Thank you very much!
