### NOTICE OF STAFF WORKSHOP

#### Central Valley Water Board Draft Pyrethroid Research Plan

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board or Board) will hold a staff workshop to discuss the comments received on the Draft Pyrethroid Research Plan and the proposed corresponding revisions. This workshop will have a similar format to the meeting held on August 1, 2023; staff will give a presentation on and answer questions pertaining to the Draft Pyrethroid Research Plan.

The Central Valley Water Board's Draft Pyrethroid Research Plan is a deliverable of the Amendment of the Water Quality Control Plan for the Sacramento River and San Joaquin River Basins for the Control of Pyrethroid Pesticide Discharges (Amendment, R5-2017-0057). This Amendment has been effective since 19 February 2019. The Draft Pyrethroid Research Plan summarizes the current state of science, and identifies research and special studies that, once completed, may inform future iterations of pyrethroid pesticide discharge regulations (e.g., potential objectives, program refinement).
