6. Cease and Desist Order R7-2024-XXXX for Biane Guard, LLC, Smoke Tree Villas Wastewater Collection Treatment and Disposal System, San Bernardino County

The Chair administered the Oath to those intending to speak on this item.

A presentation was provided by Wendy Wyels of the Prosecution Team staff describing the facility location, pertinent sections of the waste discharge requirements, and the history of violations. She then summarized the 2022 Notice of Violation and the actions taken by the Discharger in response. Additionally, she described the tentative Cease and Desist Order and the proposed revisions within the Change Sheet provided. A brief discussion was held, and Legal Counsel and staff addressed questions and comments from the Board and recommended the proposed Order be adopted with revisions identified in the Change Sheet provided by the prosecution team.

Board member Muzik recognized the Discharger's effort to improve the system and recommended allowing the extra amount of time they requested to complete the repairs.

7. Workshop on Proposed Non-Regulatory Amendment to the Water Quality Control Plan for the Colorado River Basin Region to include Tribal Beneficial Uses and Administrative Updates

Staff presented an overview on the Tribal Beneficial Uses, Statewide Mercury Provisions, and Administrative Updates Basin Plan Amendment. Board member Gonzalez congratulated Coachella Valley Water District and elected officials for obtaining \$100 million for water infrastructure in the unincorporated areas of the Eastern Coachella Valley. A celebration was held in the community, and she was pleased to see that this will now provide access to clean drinking water.
