**COMPLIANCE ORDER NO. 02\_E2\_23R\_001  
ADMINISTRATOR ORDER TO CAZADERO WATER COMPANY, INC. AND  
SELECTION OF RUSSIAN RIVER UTILITY AS THE FULL-SCOPE ADMINISTRATOR**

Enclosed is Compliance Order No. 02\_E2\_23R\_001 ("Order"), issued to the Cazadero Water Company, Inc. ("Cazadero Water Company") public water system. Please note that there are legally enforceable directives associated with this Order.

The State Water Board appreciates the willingness of the Cazadero Water Company and Russian River Utility to work together over the past several months. As discussed in the Order, the Cazadero Water Company is ordered to accept Russian River Utility as a full-scope administrator and allow Russian River Utility to exercise full authority and control over the Cazadero Water Company. The State Water Board looks forward to continuing to work with both the Cazadero Water Company and Russian River Utility as they develop a sustainable long-term solution.

Any person who is aggrieved by a citation, order or decision issued under authority delegated to an officer or employee of the State Board under Article 8 (commencing with CHSC, Section 116625) or Article 9 (commencing with CHSC, Section 116650), of the Safe Drinking Water Act (CHSC, Division 104, Part 12, Chapter 4), may file a petition with the State Board for reconsideration of the citation, order or decision.

Petitions must be received by the State Board within 30 days of the issuance of the citation, order or decision by the officer or employee of the State Board. The date of issuance is the date when the Division of Drinking Water mails a copy of the citation,

order, or decision. If the 30th day falls on a Saturday, Sunday, or state holiday, the petition is due the following business day by 5:00 p.m.
