

Subject: Scott River Watershed: Extension of Temporary Conditional Suspension of Curtailments through March 14, 2023

To: Water Right Holders in the Scott River Watershed (sent to water right holders for which the Board has email addresses and to the Scott-Shasta Drought E-mail List)

In light of current and projected flows at the United States Geological Survey (USGS) [Fort Jones gage](#), moderate forecasts for precipitation, and demand estimates, **the temporary suspension of all curtailments in the Scott River watershed is extended through 11:59 p.m. on Tuesday, March 14, 2023, as long as the required March minimum flow requirement (200 cubic feet per second [cfs]) is met and sustained at the USGS Fort Jones gage. If flows are less than the required minimum flows at the USGS Fort Jones gage (i.e., less than 200 cfs), diversions under the water rights included in List A1 (attached to this email) must cease immediately.** List A1 represents the most junior water rights in the Scott River watershed. The State Water Board will continue to monitor precipitation and flow forecasts, and watershed conditions regularly to determine if further adjustments to curtailments are appropriate.

This temporary suspension of curtailments is Addendum 44 to the Order for Reported Water Rights in the Scott River Watershed issued September 9, 2021 (for water rights included in List A), Order WR 2021-0083-DWR (for water rights included in List B), and Order WR 2021-0084-DWR (for water rights included in List C).

Please note that the prohibition of inefficient livestock watering is in effect at this time because flows at the USGS Fort Jones gage do not satisfy the conditions of [Order WR 2023-0003-DWR](#), which provides for the temporary conditional suspension of the prohibition in the Scott River watershed during high flow events. Diversions for inefficient livestock watering may resume if conditions in [Order WR 2023-0003-DWR](#) are met, which include that flows of 500 cfs are met and sustained at the USGS Fort Jones gage and diverters have notified the State Water Resources Control Board (State Water Board) of their intent to divert in accordance with the conditions the Order. Notification may be made by email to: ScottShastaDrought@waterboards.ca.gov.

The State Water Board will be monitoring weather forecasts and stream gages to determine if curtailment suspensions should be further modified or extended. The Curtailment Group number is based on the order of priority outlined in Emergency Regulation section 875.5(a)(1). Group 1 is curtailed first and suspended last (i.e., most junior water right priority), Group 7 is curtailed last and suspended first. Please note that water rights of Group 2 refer to the Surplus Rights only, not the other water rights of the owner, and that they are listed with reference to curtailment number and ownership as listed in the Scott River Decree. This list should be understood to include the successors and assigns of the owners at that time. Group 2 Surplus Rights are generally unavailable in drought years, and are only available when all other rights under the Scott River Decree have been fully satisfied.
