Dear Interested Parties:

On July 19, 2022, the State Water Resources Control Board adopted the order acting on San Joaquin County's Application 29657 that is enclosed with this letter. The Clerk of the Board will complete the final order, with order number, vote tally and clerk's certification. No later than 30 days after the date on which the Board adopted this order, any interested party may file a petition with the Board for reconsideration of the order for any of the following causes (see Water Code, § 1122; Cal. Code Regs. tit. 23, § 768): (a) irregularity in the proceedings, or any ruling, or abuse of discretion, by which the person was prevented from having a fair hearing; (b) the decision or order is not supported by substantial evidence; (c) there is relevant evidence which, in the exercise of reasonable diligence, could not have been produced; or (d) error in law.
