REVISED NOTICE OF OPPORTUNITY TO COMMENT

EXTENDED DEADLINE TO SUBMIT WRITTEN COMMENTS

PROPOSED APPROVAL OF AN AMENDMENT TO THE WATER QUALITY CONTROL PLAN FOR THE LOS ANGELES REGION (BASIN PLAN) TO INCORPORATE A TOTAL MAXIMUM DAILY LOAD FOR DEBRIS IN NEARSHORE AND OFFSHORE SANTA MONICA BAY

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will accept comments on the proposed approval of Los Angeles Regional Water Quality Control Board's (Los Angeles Water Board) amendment to the Basin Plan that would incorporate a Total Maximum Daily Load (TMDL) for Debris in Nearshore and Offshore Santa Monica Bay (Basin Plan amendment). The Basin Plan amendment was adopted by the Los Angeles Water Board on November 4, 2010, and is available for review at:

This revised notice extends the comment deadline to 12:00 noon on Thursday, October 27, 2011.**

Comment letters received after that deadline will not be accepted unless the State Water Board determines otherwise. 

Requirements for Submitting Comments (Cal. Code Regs., tit. 23, § 3779, subd. (f)). The State Water Board may refuse to accept any comments that do not satisfy all of the following requirements:

- a. Comments must specifically address the final version of the Basin Plan amendment adopted by the Los Angeles Water Board.
- b. If the Los Angeles Water Board previously responded to a similar or identical comment, the commenter must explain why and in what manner the commenter believes each of the responses provided by the Los Angeles Water Board to each comment was inadequate or incorrect. If the comment does not include such an explanation, the State Water Board will presume that the Los Angeles Water Board's response adequately addressed the commenter's concern.
