Please note that there are spaces on the Notice of Intent to Appear to provide this information. Please also note that as stated in the [Hearing Notice](#), a policy statement is a non-evidentiary statement that may only be submitted by interested persons who do not participate in the hearing as parties. (Cal. Code Regs., tit. 23, § 648.1, subd. (d).) When submitting a Notice of Intent to Appear as set forth above, Stornetta Family Trust and Newton Dal Poggetto (Trustee) may not indicate that they intend to present a policy statement.

Please submit a completed Notice of Intent to Appear by the deadline of 12:00 noon, tomorrow, Thursday, June 26, 2014.
