RESOLUTION NO. 80-59

APPROVAL OF PROPOSALS FOR PHASE IV 208 PLANNING

WHEREAS:

1. The U. S. Environmental Protection Agency (EPA) requested the State Board to submit California's recommendation on the allocation of F.Y. 1980-81 208 funds (Phase IV).
2. EPA has indicated that approximately \$2 million in federal 208 planning grant funds are available for California to conduct F.Y. 1980-81 208 planning.
3. On May 7, 1980, the State Board notified all designated 208 agencies and Regional Water Quality Control Boards of the availability of funds for F.Y. 1980-81 Water Quality Management Planning.
4. The Board received testimony on 54 proposals at public meetings held on August 20 and August 27, 1980.
5. The State Board has determined, in accordance with State and EPA criteria, that 23 projects are eligible for 208 grant funding in F.Y. 1980-81.

THEREFORE BE IT RESOLVED:

That the Board:

1. Approves the following project priorities and \$320,000 for Program Administration for 208 F.Y. 1980-81 funding:
 1. Groundwater Toxics/San Fernando Valley (SCAG) \$ 500,000
 2. Pajaro Basin Management (AMBAG) 400,000
 3. Tulare Basin Water Management (Region 5) 400,000
 4. Urban Runoff Treatment Through Wetlands Restoration (ABAG) 200,000
 5. North Coast Erosion/Sedimentation (Mendocino RCD) 182,000
 6. Toxic Waste Disposal (SRAPC) 120,000
 7. Lake Tahoe Urban Runoff (Region 6) 150,000
 8. Abandoned Water Wells (Ventura County) 139,750
 9. San Francisco Bay Shellfish (Region 2) 134,000
 10. Supplemental Instream Use Program (SWRCB) 100,000
 - *11. North Coast Pesticides (Region 1) 150,000
 - *12. Elkhorn Slough Basin Management (AMBAG) 350,000
 - *13. Mining (Region 5) 341,800
 14. Regional Groundwater Management Program (SRAPC) 190,000
 15. Erosion and Sediment Control-Geysers KGRA (SEC) 150,000
 16. Demonstration of Control Measure Feasibility (ABAG) 120,000
 17. Erosion Control and Surface Flow Management (Placer County and Placer RCD) 300,000
 18. Oxnard Plain Section 2100 (SWRCB) 187,200


*The Board directed staff to reassess priorities 11, 12, and 13 for funding if federal funding is available beyond priority 10.
