RESOLUTION NO. 85- 17

ACCEPTANCE OF THE PHASE II WATERSHED MAPPING
PROJECT AND PHASE III 208 INTERPRETATIVE EROSION
HAZARD MAPS AND FINAL REPORT FROM CALIFORNIA
DEPARTMENT OF FORESTRY AS PARTIAL COMPLETION OF
INTERAGENCY AGREEMENT NO. 0-060-118-0 AND
INTERAGENCY AGREEMENT NO. 0-090-418-0

WHEREAS:

1. The State Board is responsible for conducting Section 208 planning in accordance with the Federal Water Pollution Control Act.
2. The State Board entered into Interagency Agreements Nos. 0-060-118-0 and 0-090-418-0 with the Department of Forestry to assist the Department of Water Resources on the Phase II 208 Watershed Mapping Project and to produce a set of interpretative erosion hazard maps and a final report to accompany the maps.
3. The Interagency Agreements No. 0-060-118-0 and 0-090-418-0 were funded, respectively, by a Phase II and III 208 grant from the U. S. Environmental Protection Agency.
4. The Department of Forestry provided assistance to the Department of Water Resources on the Phase II 208 Watershed Mapping Project and combined its Phase II 208 Watershed Mapping final report with the Phase III project final report and submitted it to the State Board.
5. The Department of Forestry submitted a set of interpretative erosion hazard maps and a final report to the State Board.
6. The State Board reviewed the combined Department of Forestry Phase II and Phase III 208 Watershed Mapping final report prepared in accordance with the Interagency Agreement (No. 0-060-118-0) noting that Task E was not performed by mutual agreement.
7. The State Board has reviewed the Phase III 208 interpretative erosion hazard maps and final report prepared in accordance with the Interagency Agreement No. 0-090-418-0 noting that Task E.2 was not performed by mutual agreement.


THEREFORE BE IT RESOLVED:

That the State Board:

1. Accepts the services of the Department of Forestry in assisting the Department of Water Resources on the Phase II 208 Watershed Mapping Project and the combined Phase II and Phase III 208 Watershed Mapping Project final report as completion of Interagency Agreement No. 0-060-118-0.
2. The State Board directs the Division of Administrative Services to return \$10,085.29 to the U. S. Environmental Protection Agency and \$3,361.76 to the Clean Water Bond Fund totalling the \$13,447.05 unexpended under the Phase II agreement (No. 0-060-118-0).
3. Accepts the Phase III 208 interpretative erosion hazard maps and final report as completion of Interagency Agreement No. 0-090-418-0.
4. The State Board directs the Division of Administrative Services to return to the U.S. Environmental Protection Agency \$27,100 unexpended under the Phase III agreement (No. 0-090-418-0).
5. Notes that acceptance of the interpretative erosion hazard maps and the final report does not constitute certification of these products as Best Management Practices.
6. Directs the Executive Director to transmit a copy of the Department of Forestry combined Phase II and Phase III 208 Watershed Mapping Final Report to the U.S. Environmental Protection Agency as the final product and completion of the Department of Forestry's Phase II and Phase III 208 Watershed Mapping Projects.
