APPROVAL OF UPDATE TO FEDERAL FISCAL YEAR (FFY) 1992  
STATE REVOLVING FUND (SRF) PRIORITY LIST FOR  
NONPOINT SOURCE (NPS) AND STORM WATER PROJECTS

WHEREAS:


1. There are approximately \$101 million of FFY 1991 and 1992 funds remaining in the SRF that are available for FFY 1992 SRF projects.
2. There are several NPS and storm water projects that State Water Resources Control Board staff was not aware of when the FFY 1992 SRF Priority List was adopted in September 1991 and could be ready to proceed in FFY 1992.
3. It is appropriate to schedule additional NPS and storm water projects since many of these projects will be ready to proceed prior to adoption of the FFY 1993 SRF Priority List.

THEREFORE BE IT RESOLVED:

That the FFY 1992 SRF Priority List is hereby amended to include the NPS and storm water projects shown on Exhibit A.
