RESOLUTION NO. 92-75

AMENDMENT OF THE INITIAL UNDERGROUND STORAGE TANK (UST)  
CLEANUP FUND PRIORITY LIST

WHEREAS:

1. The Health and Safety Code authorizes the State Water Board to expend money from the UST Cleanup Fund for payment of claims against the Fund;
2. The Health and Safety Code requires the State Water Board to pay claims in accordance with a four-class priority ranking system and requires the State Water Board to adopt a priority ranking list at least twice annually;
3. The State Water Board adopted the Initial UST Cleanup Fund Priority List on July 16, 1992;
4. The Division of Clean Water Programs continues to make decisions on appeals regarding placement on the priority list; and
5. Some claimants may be delayed or otherwise harmed because a decision on their appeal was not made prior to adoption of the Initial Priority List.

THEREFORE BE IT RESOLVED THAT:

The State Water Board amends the Initial UST Cleanup Fund Priority List dated July 16, 1992 to add claims which, as the result of an appeal, have been determined to be eligible for placement on the list.
