

STATE WATER RESOURCES CONTROL BOARD  
RESOLUTION NO. 93-63

ADOPTING THE PETROLEUM UNDERGROUND STORAGE TANK (UST)  
EMERGENCY, ABANDONED, RECALCITRANT (EAR) ACCOUNT  
FY 1993-94 ANNUAL SITES LIST (ATTACHMENT 1); AND

AUTHORIZING THE EXECUTIVE DIRECTOR, OR HIS DESIGNEE,  
TO EXECUTE CONTRACTS AND AMENDMENTS WITH  
LOCAL IMPLEMENTING AGENCIES (LIAs),  
WHICH ARE DESIGNATED AS OVERSIGHT AGENCIES  
ON THE EAR ANNUAL SITES LIST.

WHEREAS:

1. Chapter 6.75 of the Health and Safety Code authorizes Regional Water Boards and Local Implementing Agencies (LIAs) to take corrective action at petroleum UST sites which have had unauthorized releases;
2. The State Water Board has established administrative procedures for providing cleanup funds to Regional Water Boards and LIAs, which include adoption of an EAR Account Annual Sites List annually, each July;
3. In October 1992, the State Water Board requested Regional Water Boards to nominate abandoned and recalcitrant UST sites, for inclusion on the FY 1993-94 EAR Annual Sites List, to receive EAR Account funding to initiate corrective action required to protect human health, safety and the environment;
4. Five Regional Water Boards responded, nominating a total of seven sites;
5. Sufficient funding is available to provide the requested funding to enable the oversight agency to initiate the required corrective action at the identified seven sites;
6. The State Water Board wishes to delegate authority to the Executive Director, or his designee, to execute contracts with LIAs, designated as oversight agencies on the Annual Sites List, pursuant to the EAR Account Administrative Procedures.


THEREFORE BE IT RESOLVED THAT:

The State Water Board hereby: (1) adopts the attached EAR Account FY 1993-94 Annual Sites List; and (2) authorizes the Executive

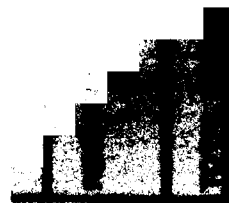
Director, or his designee, to negotiate and execute contracts with a designated LIA for the expenditure of EAR Account funds.
