**AUTHORIZATION TO EXECUTE AND AMEND  
LOCAL OVERSIGHT PROGRAM (LOP) CONTRACTS WITH AGENCIES  
TO OVERSEE LEAKING UNDERGROUND STORAGE TANK (UST)  
SITE INVESTIGATION AND REMEDIATION**

**WHEREAS:**

Leaking UST sites require remediation to protect public health, drinking water supplies and other beneficial uses of ground and surface waters.

- The State Water Board encourages qualified local agencies to participate in the oversight of the investigation and remediation of leaking petroleum USTs.
- The LOP has been established pursuant to Section 25297.1 of the Health and Safety Code to provide funds to local agencies for the oversight of investigation and remediation at leaking UST sites.
- Sufficient funds have been included in the State Water Board budget for local agency contracts to oversee leaking UST sites.
- The LOP contracts include priorities and performance measures in an effort to effect efficient, cost effective, and expedient site remediation.
