SUBJECT

CONSIDERATION OF A RESOLUTION AUTHORIZING THE EXECUTIVE DIRECTOR, OR DESIGNEE, TO SIGN A COOPERATIVE AGREEMENT WITH THE DEPARTMENT OF THE NAVY TO PROVIDE REGULATORY OVERSIGHT OF SITE REMEDIATION ACTIVITIES AT ALL NAVY FACILITIES

DISCUSSION

The State Water Resources Control Board and the Regional Water Quality Control Boards (California Water Boards) conduct regulatory oversight for the cleanup of many of the active and closing military facilities in California. The funding mechanism for regulatory oversight has been through a Defense State Memorandum of Agreement (DSMOA).

In March 2003, the Department of the Navy requested that all Navy facilities be placed in the Navy Cost Recovery Program. As a result of this funding mechanism change, a Navy Cooperative Agreement (CA) was negotiated, which is patterned after the Spills, Leaks, Investigations, and Cleanup Program. Consequently, the Department of the Navy is billed directly, on a quarterly basis, for cleanup oversight activities provided by the Regional Water Quality Control Boards (Regional Water Boards). The Navy facilities are listed in the attachment. This item would allow for renewal of the CA.

POLICY ISSUE

Should the State Water Resources Control Board (State Water Board) be a party to the proposed CA as a mechanism to ensure timely recovery of costs incurred in regulatory oversight of cleanups at all Navy facilities?

FISCAL IMPACT

The Fiscal Year (FY) 2005-2006 budget for regulatory oversight at Navy facilities is approximately \$3,000,000. The California Water Boards' staff work associated with this oversight can be accomplished within these budgeted resources.

REGIONAL WATER BOARDS IMPACT

Yes, all Regional Water Boards, with the exception of the Central Coast Water Board, which has no Navy facilities with work planned during FY 2005-2006.

STAFF RECOMMENDATION

That the State Water Board authorize the Executive Director, or designee, to sign the new Navy CA.

STATE WATER RESOURCES CONTROL BOARD RESOLUTION NO. 2005-

AUTHORIZING THE EXECUTIVE DIRECTOR, OR DESIGNEE, TO SIGN A COOPERATIVE AGREEMENT WITH THE DEPARTMENT OF THE NAVY TO PROVIDE REGULATORY OVERSIGHT OF SITE REMEDIATION ACTIVITIES AT ALL NAVY FACILITIES

WHEREAS:

1. The Department of the Navy and the State Water Resources Control Board (State Water Board) moved all of the Navy facilities from the Defense State Memorandum of Agreement (DSMOA) and placed those facilities into the Navy Cost Recovery Program, effective March 1, 2003.
2. The Department of the Navy has requested and negotiated a Cooperative Agreement to reimburse the State Water Board and Regional Water Quality Control Boards (California Water Boards) for regulatory oversight at all Navy facilities.
3. The Department of the Navy will be billed directly, on a quarterly basis, for oversight activities performed by the California Water Boards.

THEREFORE BE IT RESOLVED THAT:

The State Water Board authorizes the Executive Director, or designee, to sign a Cooperative Agreement with the Department of the Navy for reimbursement or regulatory oversight at all Navy facilities.
