- Projects in Classes A and B are eligible to compete for available funds. Projects will be processed and grants will be issued on a readiness-to-proceed basis until all the funds are fully committed. Projects from the 2004 Statewide Competitive Project List (CPL) will not be given priority over projects added in 2007.
- Small Community Wastewater Grant (SCWG) funding has been capped at a maximum of \$2 million per community.
- Projects that have already received a construction grant commitment or a design/construction grant commitment (totaling \$2 million) are not eligible for additional funding at this time.
- Information provided in the 2007 Initial Scope of Work Forms indicates that multiple applications have been submitted to address one or more problems associated with the same community. The maximum funding cap has been set at \$2 million per community. Therefore, regardless of the number of applications submitted, a community will only be eligible for a maximum of \$2 million in SCWG funds. If multiple Initial Scope of Work Forms have been submitted for the same community, the \$2 million maximum will need to be allocated accordingly.
- The United States Census, County, or other Median Household Income (MHI) data provided by the applicant in the Initial Scope of Work Form exceeds the SCWG eligibility criteria. An income survey must be conducted to determine whether or not the community is eligible for a SCWG.
- As a result of further review of supporting documentation (following adoption of the 2004 CPL), this project has been moved from Class C up to Class B.
- Three Class C projects (Sonoma County Water Agency- Camp Meeker, City of Holtville- Holtville Wastewater Treatment Facility Upgrade, and City of La Puente- City of La Puente Sanitary Sewer Rehabilitation) have been removed from the 2004 CPL because it was determined (following adoption of the 2004 CPL) that the population and/or MHI eligibility criteria for the SCWG Program was not met.
- The total population exceeds the eligibility criterion 20,000 persons or less.
- Nine Initial Scope of Work Forms were submitted by the City of Maywood, three forms (one for the planning phase, one for the design phase, and one for the construction phase) for each of three proposed Neighborhood Sewer Rehabilitation Projects (Zone 1, Zone 2, and Zone 3). Since the three forms submitted for each Zone address only different phases of the same overall construction project, each zone has been listed only once, and assigned a single project number.
- As a result of further review of supporting documentation (following adoption of the 2004 CPL), this project has been moved to Class C.
