**PLEASE TAKE NOTICE**

The Deridere Aper Vinea, LP Hearing scheduled to commence on February 13, 2017, identified in the January 4, 2017 [Notice of Public Hearing](#) is **cancelled**.

The State Water Resources Control Board scheduled a hearing: 1) to receive evidence relevant to determining whether Deridere Aper Vinea, L.P. violated regulations or the terms or conditions of any permit or license requiring the filing of a Progress Report by Permittee or Report of Licensee (collectively, Annual Water Use Report); and 2) if a violation occurred, to determine the amount of administrative civil liability and adopt an order imposing civil liability upon the Respondent.

Deridere Aper Vinea, LP and the Board's Division of Water Rights' Prosecution Team requested postponement of the hearing and entered into a settlement agreement on February 24, 2017. By [Notice of Postponement of Public Hearing](#), dated February 10, 2017, the State Water Board postponed the February 13<sup>th</sup> hearing. On March 2, 2017, the State Water Board's Executive Director issued Water Right Order [WR 2017-0006-EXEC](#) (Order Approving Settlement

Agreement). Accordingly, no hearing is required to be held on this matter and the previously scheduled hearing is **cancelled**.
