NOTICE OF PUBLIC MEETING

TO CONSIDER A RESOLUTION APPROVING THE PROPOSED AMENDMENTS TO THE WATER QUALITY CONTROL PLANS FOR THE SACRAMENTO RIVER AND SAN JOAQUIN RIVER BASINS AND THE TULARE LAKE BASIN TO INCORPORATE A CENTRAL VALLEY-WIDE SALT AND NITRATE CONTROL PROGRAM

NOTICE IS HEREBY GIVEN THAT the State Water Resources Control Board (State Water Board) will hold a public meeting at which it will consider adopting a proposed draft resolution approving the proposed Central Valley Regional Water Quality Control Board's (Central Valley Water Board's) amendments to the Sacramento and San Joaquin Basin Plan and the Tulare Lake Basin Plan to incorporate a Central Valley-wide Salt and Nitrate Control Program and also directing the Central Valley Water Board to make targeted revisions to the Basin Plan amendments within one year from the approval of the Basin Plan amendments by the Office of Administrative Law. The Basin Plan amendments were adopted by the Central Valley Water Board on May 31, 2018 ([Resolution No. R5-2018-0034](#)). The proposed draft resolution and Response to Comments are available on the October 16, 2019 SWRCB Board Meeting agenda.
