State Water Resources Control Board August 17, 2021 – Item 6 Executive Director's Report

DIVISION OF WATER QUALITY

Grazing Guidance Outreach: State Water Board staff in the Nonpoint Source Unit conducted a series of outreach meetings with targeted stakeholders about the statewide Grazing Guidance under development, a document that will build on and update the 1995 Rangeland Water Quality Management Plan. Meetings were held on July 26, August 2, and August 9, and topics of discussion included management practices to reduce water quality impacts, challenges to implementing management practices, and how the Water Boards can be allies in grazing management in California.

Public Outreach During Development of Statewide Water Quality Orders:

State Water Board staff continues to work closely with interested parties during the development of statewide permits and orders. A primary focus of ongoing outreach is to identify the funding and technical assistance needs of disadvantaged communities through continued outreach for the following projects:

Development of Statewide Municipal Stormwater Permit for Small Communities: State Water Board staff is actively developing a draft reissuance of the existing Statewide Phase II Municipal Stormwater Permit for Small Communities. In addition to the June 2020 public workshops and corresponding focused meetings with representatives of the California Association of Stormwater Agencies, municipalities, school district, and nongovernmental organizations, State Water Board staff is reaching out to the Department of the State Architect and environmental justice organizations to address logistical issues regarding the regulation of stormwater from school sites and small communities located within larger regulated municipalities. Ongoing discussions will focus on how to merge stormwater discharge requirements for small regulated municipalities with that for larger municipalities to take advantage of the economy of scale for both cost and technical expertise. A common goal of numerous interested parties is to merge regulatory requirements and costs in a manner that maximizes local and regional stormwater capture and reuse, providing multiple benefits including water supply augmentation.

Development of Statewide Sanitary Sewer System General Order:

State Water Board staff has conducted numerous public workshops, outreach events and focused meetings prior to, and after, the recent release of an informal staff draft of a proposed Statewide Sanitary Sewer System General Order reissuance. Staff: (1) held weekly informal discussions with California Association of Sanitation Agency representatives, (2) is attending local system operator business meetings and forums, (3) is continuing to hold technical discussions with representatives of the California Coast Keepers Alliance, and (3) is working closely with representatives of the California Water Environment Association for development to ongoing training for regulated system operators and managers. State Water Board staff is also reaching out to representatives of environmental justice organizations, and sewer system operators of

small disadvantaged communities, to understand the challenges of securing funding and accessing the technical assistance they need. Rather than considering relaxing regulatory requirements that assure safe and sanitary conditions for disadvantaged communities, Water Board staff is focusing on assisting disadvantaged communities to obtain the necessary resources to have resilient sanitary sewer systems.

Toxicity Study Stakeholder Advisory Committee Meeting:

The State Water Board contracted with the Southern California Coastal Water Research Project Authority (SCCWRP) to conduct a study to evaluate laboratory performance when conducting the *Ceriodaphnia dubia* chronic aquatic toxicity test method, produce a report that summarizes the study results, and provide recommendations to improve toxicity data quality and comparability for the *C. dubia* chronic aquatic toxicity test method.

SCCWRP staff are currently compiling data from environmental toxicology laboratories that are accredited by the State Water Board to conduct the *C. dubia* chronic aquatic toxicity test method. Data compilation is expected to be completed by the end of August 2021, and initial data analyses are expected to begin in September 2021.

The study is being guided by a Stakeholder Advisory Committee and an Expert Panel. The Stakeholder Advisory Committee is expected to meet again in September 2021, and the Expert Panel is expected to meet again in October 2021. The study is scheduled to be completed in March 2023, with a presentation to the State Water Board by July 2023.

DIVISION OF WATER RIGHTS

Drought-related Items

<u>Scott and Shasta Rivers</u>: On July 1, 2021, State Water Board staff held a public meeting with California Department of Fish and Wildlife (CDFW) staff to provide information and solicit input from the community on potential drought actions that could be implemented in the Scott River and Shasta River watersheds during the ongoing drought. On July 16, 2021, the State Water Board released a draft drought emergency regulation for the Scott River and Shasta River watersheds for public comment. The

draft drought emergency regulation included drought emergency minimum instream flow requirements for Coho and Chinook salmon provided by CDFW in its June 15, 2021 letter to the Board requesting an emergency regulation for the Scott River and Shasta River watersheds. On July 20, 2021, State Water Board staff held a public meeting with CDFW staff to provide information and solicit input on the draft regulation. By the close of the public comment period on the draft regulation (July 23, 2021), State Water Board staff received 100 comment letters. Staff are reviewing the comments to determine potential updates to the drought emergency regulation. > Permitting and Enforcement Branch

SB 88 Water Measurement Regulation Notices of Violation: In July 2021, the Permitting and Enforcement Branch of the Division of Water Rights began sending Notices of Violation to diverters who have not submitted the required information about SB 88 water measurement devices or water measurement data. Water diverters have been required to measure and report their water use under SB 88 since 2016, and Division staff have been providing information and technical assistance to help diverters comply for 5 years. Water right holders who divert more than 1,000 acre-feet and have not yet registered their water measurement devices or submitted the required water diversion measurements received the Notices.

Staff are providing comprehensive compliance assistance to help diverters complete missing reports, report in the correct units, and upload their data to the right location. In addition, staff is providing flexibility to allow submittal of provisional data, and providing additional time to correct the provisional data. Timely, accurate diversion information helps protect the water rights priority system and provides drought resilience for communities and the environment.

> Delta, Hearings, and Special Projects Branch

Emergency Regulations for Curtailment of Water Rights in the Delta Watershed:

On July 27, 2021, the State Water Resources Control Board held a public workshop on the draft curtailment and reporting regulations for diversions in the Sacramento and San Joaquin River Delta watershed that was released for public comment July 23. Staff presented a summary of the regulations and methodology, solicited input and answered questions from stakeholders.

On August 3, 2021, the State Water Board adopted emergency regulations for curtailment of water rights in the Delta watershed with measures to preserve stored water to protect drinking water supplies, prevent salinity intrusion and minimize impacts to fisheries and the environment. The emergency regulation must be approved by the Office of Administrative Law and filed with the Secretary of State before it becomes effective and curtailment orders can be issued.

Water Quality Certification, Public Trust, Cannabis, Administrative, & Reporting Branch

Yuba River Development Project: The public comment period for responses to petitions for reconsideration regarding the July 17, 2020 water quality certification for Yuba County Water Agency's Yuba River Development Project (Project) concluded on July 30, 2021. The State Water Board received comments from four entities: Yuba County Water Agency; National Marine Fisheries Service; Merced Irrigation District; and a group of nongovernmental organizations including the California Sportfishing Alliance, Friends of the River, Sierra Club Mother Lode Chapter, South Yuba River Citizens League, and Trout Unlimited. <u>Water Rights Annual Water Use Reporting</u>: Annual reports for 2020 water use for riparian and pre-1914 water rights (supplemental statements) as well as groundwater recordation were due July 1, 2021. As of the deadline, the percentage of timely filed reports is: 69 percent of supplemental statement reports and 73 percent of groundwater recordation reports. In comparison to last year's (2019 water use) reporting compliance as of the filing deadline, supplemental statements compliance is within the same range (up one percent) and groundwater recordation is up three percent.

The annual water use reports for 2020 water use under appropriative water rights (permits, licenses, registrations and stockponds) were due April 1, 2021. The table below outlines reporting compliance as of the deadline (April 1) as well as updated compliance information as of July 30.

Saddlebag Lake Flume Replacement Project: On July 23, 2021, the Executive Director issued a water quality certification for Southern California Edison Company's Saddlebag Lake Flume Replacement Project (Project). The Project consists of removal and installation of a Parshall flume downstream of Saddlebag Lake to ensure continued accuracy of flow release measurements in Lee Vining Creek from the Lee Vining Hydroelectric Project (Federal Energy Regulatory Commission Project No. 1388). The Project is located on Lee Vining Creek, nine miles west of the town of Lee Vining in Mono County. The Project is anticipated to take approximately four weeks to complete in early fall 2021.

The Division of Financial Assistant (DFA) staff is continuing to coordinate with the State Historic Preservation Officer staff to discuss next steps in the development of a Programmatic Agreement under Section 106 of the National Historic Preservation Act. The Agreement will provide the State Water Board more authority to complete Clean/Drinking Water State Revolving Fund (SRF) project reviews in-house.

DFA staff is finalizing the Drinking Water SRF Program State Environmental Review Process and will send to the United States Environmental Protection Agency (U.S. EPA) Region 9, Regional Administrator for approval.

DFA staff is coordinating with the U.S. EPA Region 9 SRF staff to start revision process on the Clean Water SRF Environmental Review Process.

DIVISION OF DRINKING WATER

New Drinking Water Regulations Effective July 1, 2021

Two new drinking water regulations took effect July 1, 2021. The Revised Total Coliform Rule (RTCR) and a revised perchlorate detection limit for purposes of reporting (DLR).

On May 28, 2021, the Office of Administrative Law approved the Revised Total Coliform Rule adopted by the State Water Board on February 2, 2021. The RTCR includes a new *E-coli* MCL and a coliform treatment technique requirement that replaces the total coliform MCL. The RTCR establishes a "find-and-fix" approach for investigating and correcting causes of microbial contamination and requires public water systems that continuously disinfect groundwater sources to collect a raw water coliform sample once a quarter. On June 17, 2021, the Office of Administrative Law approved the perchlorate DLR regulations adopted by the State Water Board on October 6, 2020. The DLR changed from 0.004 mg/l to 0.002 mg/l on July 1, 2021 and will further decrease to 0.001 mg/l on July 1, 2024. Permits

Permits are issued when a public water system undertakes action that may impact public health (i.e. a new source of supply, modifying treatment or adding a large distribution reservoir), when the original permit has numerous amendments, or following new regulations or conditions that DDW deems necessary for the protection of public health.

The following 174 permits were issued between June 26 and July 25, 2021. Permits showing "transfer to DDW" are public water systems being returned by counties giving back their Local Primacy Agency (LPA) programs such as San Diego County and Amador County.

Roadmap to ELAP Accreditation

ELAP continues to support laboratories in transitioning to new regulatory requirements through a compliance assistance initiative, the Roadmap to ELAP Accreditation, including one-on-on Transition Appointments with individual laboratories to answer questions and help them create a plan. Laboratories may request an appointment by emailing ELAP's general email inbox.

The ninth and tenth session of the TNI Quality System Documentation Workshop were delivered in July and registration is now open for sessions through the end of 2021. The virtual workshop is broken into four parts over the course of two days with a maximum of 30 attendees per class. The workshop includes an introductory course about the TNI Standard and its requirements. The workshop materials provide fillable templates, requirements & explanations, examples of Policies & Procedures, Job Aid to identify where the TNI Standard requires specific policies, procedures, and records. The meetings are being recorded and edited for posting on ELAP's website.

National Environmental Monitoring Conference 2021

ELAP staff will present at the National Environmental Monitoring Conference hosted by the US EPA and the NELAC Institute. Staff will present at three different sessions – an enforcement case study on inappropriate laboratory practices, operational issues impacting the environmental laboratory industry, and efforts to accredit laboratories for monitoring of microplastics in California.

ELTAC Meeting

ELAP's advisory committee, ELTAC, met for the second time in 2021 on July 30, 2021. This meeting largely focused on Water Boards programs that had new or upcoming requirements that needed a new methodology. Water Boards programs included were DDW for Microplastics, DWQ for the Winery Order, and Central Valley Water Board for Imidacloprid.

ELTAC Subcommittee on Method Selection for Regulatory Testing

ELTAC created a subcommittee in January 2021 to develop guidance on how laboratory methods should be developed and what criteria California's regulatory agencies should consider when selecting laboratory methods to utilize for their regulatory programs. The subcommittee held its fifth meeting on July 12, 2021 where they distributed and discussed a draft of its guidance document. Work will continue and progress will be discussed during the next meeting to be scheduled.

DDW & DWQ PFAS Strategy Team

ELAP staff continues to regularly participate in the multi-divisional strategy team for regulation of PFAS. New staff are being brought into the project to build a robust knowledge base and provide additional technical assistance.

Recycled Water:

On July 21, 2021, an inspection of the second largest UltraViolet (UV) disinfection plant in the country was conducted at the Los Angeles Department of Water and Power (LADWP) 650 million gallon per day (MGD) facility to disinfect water out of the Los Angeles Reservoir (LAR) to meet the Long Term 2 Surface Water Treatment Rule. The LAR UV system is designed to disinfect and inactivate 99.9% Cryptosporidium via 15 UV reactors that are 48-inch in diameter and can disinfect up to 50 MGD each.

That afternoon, the same staff toured the Donald C. Tilman (DCT) Reclamation Plant that treats up to 80 MGD. The plant provides recycled water to many users in the San Fernando Valley and the City of Los Angeles Department of Public Works. DCT is upgrading their treatment with a 10 MGD side stream ozonation plant, which will provide water to spread at the Hanson recharge basins. The project will replenish the San Fernando groundwater basin.

The final stop of the day was an inspection of the Hanson Spreading Grounds (HSG). Rainwater and stormwater runoff from the San Gabriel mountains is currently spread to replenish the groundwater basin. The highly treated recycled water from the ozone plant at DCT will supplement the water supply via wells in the San Fernando Valley. At the time of the inspection of HSG, the spreading basins were completely dry, which is a sign of the drought and the need for resilient new water sources such as treated recycled water from DCT.

SAFER Engagement Units

Administrator Process Initiated for Teviston Community Service District

A letter of intent to designate Teviston Community Service District as a public water system in need of an administrator was sent by the Division on July 16, 2021. The need for an administrator is based on the failure to obtain compliance with the 1,2,3-trichloropropane maximum contaminant level by the compliance order deadline of April 30, 2021, and failure to properly maintain existing infrastructure to ensure an adequate supply of water for its residents at all times.

Water Partnership Workshop Virtual Events on July 15, 2021 and July 22, 2021 On July 15, 2021 and July 22, 2021, the SAFER Engagement Units held its first two virtual water partnership workshops in Monterey and Kern counties, respectively. The purpose of the workshop was to learn how water system partnerships can benefit water systems and how to leverage resources to increase Technical, Managerial, and Financial (TMF) capacity. The workshop also offered two free contact hours for water operators. Some of the topics discussed were background information on the area, partnership overview, funding opportunities, and partnership success stories. Attendees had the opportunity to participate in breakout rooms to discuss current challenges and possible partnership solutions. The SAFER Engagement Units will be hosting 14 additional Virtual Water Partnership Workshops in 2021. Upcoming workshops can be found at the website below:

The SAFER Engagement Units also sent out approximately 130 letters to public water systems and/or state small water systems this month inviting them to the workshops and/or recommending that they investigate consolidation.

Prevention of new public water system

In March 2021, Caltrans submitted a preliminary technical report for their proposed public water system, SB Cottonwood Commercial Vehicle Enforcement Facility (Cottonwood), for review. After review of their application, the Northern SAFER Engagement unit in conjunction with the Valley District, determined that consolidation with Caltrans' NB Cottonwood CVEF water system was feasible and would be the most cost-effective option. On July 8, 2021, Caltrans informed the State Water Board of their intention to abandon pursuit of having a new on-site water system in favor of connecting water supply from their existing public water system.

New Orchard Consolidation

New Orchard Mobile Home Park served 53 customers through 43 service connections. This water system operated two groundwater wells to meet its drinking water demand-both of which exceeded the arsenic maximum contaminant level. On January 29, 2009, Tehama County Environmental issued a Compliance Order No. 01-21-09(02) to the water system for violating the arsenic primary drinking water standard. In 2009, a compliance report prepared by professional engineers of Nolte Associates, established that the preferred alternative for New Orchard to comply with the arsenic standard was for New Orchard to consolidate with the Los Molinos CSD. The construction project included a production well (Well No. 5) within Los Molinos Community Services District service area and transmission pipeline to consolidate New Orchard Mobile Home Park as well as Millstream Mobile Home Park. New Orchard Mobile Home park was physically connected to Los Molinos CSD on June 22, 2021.

<u>Lean Six Process Improvement Event for Administrator Process – July 8 & 9, 2021</u> The SAFER Engagement team did a two-day intensive administrator process improvement event. During the event, staff mapped current administrator process flows, estimated project touch times and lead times for all tasks and identified 21 process improvements to increase efficient on administrator projects.

The meeting included presentations by several partner staff including a talk by Southern California Coastal Water Research Project on a watershed prioritization tool, California Natural Resources agency staff presentation on the California FORESITE project and an update on Surface Water Ambient Monitoring Program (SWAMP) staff's efforts to develop a watershed assessment dashboard/tool. SWAMP staff are working closely with each of the related project leads to ensure these watershed protection and restoration resources are coordinated and consistent. California Freshwater Harmful Algal Bloom August Status Update: With water levels lower this year, harmful algal blooms (HABs) have been more prevalent throughout the state. Water bodies are experiencing longer blooms and earlier in the year. This year, the Interagency HAB-related Illness Workgroup has already investigated over 40 potential HAB-related illnesses in human and animals in California as compared to 24 in 2019 and 29 in 2020. In late July, the Water Board issued a press release for the Trinity River for toxic algal mats in response to a potential toxic algae-related dog death. The Water Boards, working with Trinity County, have posted advisory signage on miles of the river. The Water Boards is also currently working with Sonoma County for a second press release this summer for the Russian River. The HAB Program is currently gearing up for the last holiday assessment aimed for Labor Day. Water Board staff work with partnering agencies to perform sampling and populate the HAB Incident map for the public to reference before recreating in some of the more popular waterbodies over the major holiday weekend.

OFFICE OF RESEARCH, PLANNING, AND PERFORMANCE

Water Conservation

The response rate for the June 2021 Urban Water Conservation Report is 89% as of the writing of this report (367 reports submitted). Of the submitted reports, 321 of the reports provide final production numbers, while 46 of the reports indicate that the production data is preliminary. The estimated total production (accounting for missing reports) is 190.8 billion gallons, and the statewide R-GPCD is 111 GPCD. 88 out of the 367 reports (24.0%) indicate that the reporter's agency is experiencing a water shortage greater than 10% of the agency's water supply.

COVID-19

The water shutoff reporting site received 10 reports for the month of July.

Climate Change

Facilitation of regular meetings continues with Regional Water Board 1 and the Coastal Commission on the Arcata wastewater treatment facility's planned upgrades that conflict with impending sea level rise.

IRRIGATED LANDS REGULATORY PROGRAM UPDATE July 2021

This month's Irrigated Lands Regulatory Program (ILRP) update provides a summary of significant activities of State Water Resources Control Board (State Water Board) from June 15, 2021 to July 15, 2021, and the Central Valley Regional Water Quality Control Board's (Regional Water Board) Program from May 15, 2021 to July 15, 2021. Next month's report will present activities of the North Coast, San Francisco Bay, Central Coast, Los Angeles, Lahontan, Colorado River Basin, Santa Ana and San Diego Regional Water Boards' Programs and cover the time period from June 15, 2021 to August 15, 2021.

State Water Board staff continue assisting the regions in GeoTracker modification and implementation. Primarily, staff has been working with the Central Coast Regional Water Board staff to modify their reporting forms for the recently adopted Agricultural Order.

The **Central Valley Water Board** will consider a resolution to exempt the Goose Lake Subwatershed (Modoc County) from the ILRP during the August Board Meeting. The recommendation is based on Central Valley Water Board staff work with UC Rangelands to gather information and evaluate regulatory options for the ILRP to be more relevant and meaningful for irrigated pasture and low-threat crops in the upper watersheds. The information included pesticide use data, nitrogen/fertilizer use data, management practice data, geographic data, and economic analysis results. All comment letters received on the draft resolution have been in support of the effort.

Also scheduled for the August Central Valley Water Board meeting is an information item regarding the on-farm drinking water well monitoring program, required by State Water Resources Control Board Order WQ-2018-0002. This program is initiated in eleven coalition areas, with over 7,000 wells monitored for nitrate and nitrite as nitrogen. The monitoring data is publicly available on GeoTracker.

Central Valley Water Board staff hold regular ILRP stakeholder meetings to provide an open forum for communication between staff, agricultural coalitions, environmental justice groups, and other interested parties in Central Valley Region. The last meeting was held on July 14th and focused on the development of Groundwater Protection Values.
