- 1. Report by Bruce Wolfe, San Francisco Bay Regional Water Quality Control Board Executive Officer, on regional board activities, presented a power point <u>presentation</u>.
- 2. Report by Celeste Cantú, State Water Board Executive Director, on the status of the implementation of the agricultural waiver memorandum of understanding:

Ms. Cantú addressed the Board about an MOU signed on June 29, 2005, for a Pilot Program among the State Water Resources Control Board, the Central Valley Regional Water Quality Control Board (Central Valley Water Board), the Agricultural Commissioners of Butte and Glenn Counties, and the Department of Pesticide Regulation (DPR) relating to the Central Valley Water Board's Conditional Waiver of Waste Discharge Requirements for Discharges from Irrigated Lands. The MOU has been progressing smoothly given that it is still in the initial stages, including the development of contract language for the two contracts between the counties and the Central Valley Water Board.

The Central Valley Water Board staff and the two County Agricultural Commissioners have worked through the details and recently signed the two contracts. These efforts demonstrate the working relationship is off to a very good start with good communication and clear understanding between the parties.

Some of the specific issues the Central Valley Water Board staff and the two County Agricultural Commissioners have discussed and resolved include:

- 1. One staff person at the Central Valley Water Board and in each county identified as a liaison or point of contact to facilitate clear communication and efficiencies.
- 2. Entry onto private property for Conditional Agricultural Waiver monitoring purposes will provide an opportunity to address and clarify expectations when problems are observed,

with a clear understanding and consensus that the priority is to promote compliance through information sharing, but that there is an enforcement component.

The contracts provide for program support equal to a half PY in each county for the Irrigated Lands Program by providing inspections of watershed monitoring locations, assisting in identifying sources of water quality exceedances, providing information on watershed activities, and conducting/coordinating public education and outreach programs concerning Irrigated Lands Program, its requirements, and management practices to protect water quality. The contracts describe the above in detail through five specific tasks to be performed and a schedule for their completion.

TASK 1: The counties will provide information and inspect and investigate sites for the Irrigated Lands Program as authorized by the Central Valley Water Board.

- a. Maps currently available from the counties delineating natural water bodies and constructed agricultural drains and canals are examples of information that will be provided. While addressing such issues as "what constitutes an agricultural drain for mapping purposes," the Glenn County Agricultural Commissioner has demonstrated to Central Valley Water Board staff its County-wide GIS Permitting Program.
- b. As authorized by the Central Valley Water Board Contract Manager, the counties will perform five pesticide application inspections each year (in addition to inspections conducted for DPR) based on water quality issues identified by the Central Valley Water Board, Coalition Groups/Individual Dischargers, or the Ag. Commissioner.
- c. As authorized by the Central Valley Water Board Contract Manager, perform investigations to identify sources of water quality exceedances.

<u>TASK 2</u>: Inspect, assess, and document management practices used in agricultural operations to protect water quality.

- a. Inspect a minimum of five sites to identify management practices that protect water quality and determine their effectiveness.
- b. Identify, evaluate, and document management practices that are specific and appropriate to activities and operations within a watershed.
- c. Take part in the development of integrated management practices to protect water quality.

<u>TASK 3</u>: Assist the Central Valley Water Board in evaluating sample monitoring points for agricultural wastewater discharges within the county.

a. Provide a list of pesticides being used in the county and inform the Central Valley Water Board when new pesticides are used.

<u>TASK 4</u>: Coordinate and conduct outreach to growers on management practices that protect water quality.

- a. Participate in outreach programs to assist Irrigated Lands Program participants in complying with management practices to protect water quality.
- b. Evaluate outreach efforts and help Central Valley Water Board staff design outreach programs on management practices to protect water quality.

<u>TASK 5</u>: Assist Central Valley Water Board staff by providing information and input that will further the implementation of the Irrigated Lands Program.

a. Coordinate with other agencies associated with agricultural operations on management practices that protect water quality.
