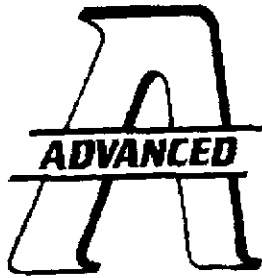

Concrete Tank Repair Warranty

We warrant the repairs to the interior walls and baffle of the septic tank located at: 1399 14th Street Los Osos, CA 93402, to be free from defects in materials and workmanship for a period of three (3) years from the date of invoice.

Exclusions

This warranty does not cover damages as a result of earthquake, fire, flood, or operation of heavy machinery, impact or compaction equipment above or near the tank, damage from tree root pressure, or natural disaster.

This warranty does not cover damage caused by negligence on the part of the owner, or abuse of the system due to overloading, use of non-household chemicals, caustics, acids, paints or solvents.

This warranty is not a guarantee of leachfield performance, or against clogs or stoppages in the sewer or tank plumbing, or the need for periodic maintenance pumping every 3 years.

Owners/buyers full and complete remedy under this warranty is limited to the cost of the tank repair only.
