### **ORDER AMENDING CLEAN WATER ACT SECTION 401 TECHNICALLY CONDITIONED WATER QUALITY CERTIFICATION; KB HOME SACRAMENTO INC., VINTAGE PARK ESTATES PROJECT (WDID#5A34CR00701A1), SACRAMENTO COUNTY**

This Order responds to the 29 October 2020 request for an amendment of the Vintage Park Estates Project (Project) Section 401 Water Quality Certification (WDID#5A34CR00701). The original Water Quality Certification (Certification) was issued on 21 September 2017. The requested amendment is hereby approved. The original Certification is therefore amended as described below. Please attach this document to the original Certification.

#### **AMENDMENT:**

Roman Catholic Bishop of Sacramento is requesting an amendment to the existing 401 Water Quality Certification. The amendment requests a change in the Permittee name to reflect a change in ownership.

The Certification is amended to reflect the change in ownership from Thomas McNamara with Roman Catholic Bishop of Sacramento to Alberto Esquivel of KB Home Sacramento, Inc. KB Home Sacramento, Inc. has accepted the responsibility to implement the Certification's requirements and the responsibility for compliance with any long-term Best Management Practices maintenance plan requirements.

#### **APPLICATION FEE RECEIVED:**

No fee was required for this amendment. An application fee of \$4,342.00 for the original Certification were received on 13 April 2017. An additional fee of \$275.00 based on the
