CHANGE OF NAME AND/OR OWNERSHIP OF FACILITIES
HAVING WASTE DISCHARGE REQUIREMENTS

The California Regional Water Quality Control Board, Central Valley Region, finds that:

1. The Regional Board Orders listed below are for facilities that have had a change of name and/or ownership since adoption of the Orders.
