ORDER R5-2014-0027

**RESCINDING WASTE DISCHARGE REQUIREMENTS/NPDES PERMITS**

- a. **BUTTE COUNTY SERVICE AREA #135, KEEFER CREEK HOME OWNERS ASSOCIATION, BUTTE COUNTY (FACILITY).** Waste Discharge Requirements Order No. 95-261, adopted on 8 December 1995, prescribes requirements for the discharge from the Butte County Service Area #135, Keefer Creek Home Owners Association, Butte County (Facility). The Facility discharges domestic wastewater through onsite Orenco AdvanTex AX-100 Textile filters to a leach field. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 95-261.
- b. **RECLAMATION DISTRICT NUMBER 800 DISCOVERY BAY MAINTENANCE DREDGING, CONTRA COSTA COUNTY.** Waste Discharge Requirements Order No. R5-2003-0027, adopted 31 January 2013, prescribes waste discharge requirements for Reclamation District 800 maintenance dredging of Discovery Bay in Contra Costa County. The waste discharge requirements (WDR) authorized an initial 153,000 cubic yards of dredging and subsequent dredging of 50,000 cubic yards annually thereafter. Reclamation District 800 has requested in a letter dated 17 December 2013, that the WDR be rescinded, as no dredging has taken place under these WDR's since the initial dredging operation in 2003, and no further dredging is anticipated in the foreseeable future. Because there are no further dredging operations anticipated, the WDR's are no longer necessary and Order R5-2003-0027 should be rescinded. (PG)
- c. **VENVIROTEK AND KERN COUNTY, VENVIROTEK ARVIN FACILITY, KERN COUNTY.** Waste Discharge Requirements Order 92-199, adopted 25 September 1992, prescribes waste discharge requirements for treating nonhazardous liquid and solid wastes at VenVirotek's facility at Kern County's landfill in Arvin, Kern County. The facility has been clean-closed. All structures and wastes have been removed from the site. Because there are no further operations at this site and no observed threat to water quality, the waste discharge requirements are no longer necessary. It is appropriate to rescind Order 92-199. (REH)
- d. **ANDERSON UNION HIGH SCHOOL DISTRICT WEST VALLEY HIGH SCHOOL, SHASTA COUNTY (FACILITY).** Waste Discharge Requirements Order No. 98-210, adopted on 23 October 1998, prescribes requirements for the discharge from the Anderson Union High School District West Valley High School, Shasta County (Facility). The Facility consists of a wastewater collection system and lift station discharging to two

evaporation/percolation ponds. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order No. 98-210.

- e. **UNITED STATES DEPARTMENT OF THE INTERIOR, NATIONAL PARK SERVICE, WHISKEY CREEK RECREATION AREA, SHASTA COUNTY (FACILITY).** Waste Discharge Requirements Order No. 86-203, adopted on 24 October 1986, prescribes requirements for the discharge from the United States Department of the Interior, National Park Service, Whiskey Creek Recreation Area, Shasta County (Facility). The Facility consists of a day-use-only public sanitary facility with a total of five flushing toilets. Wastewater discharges to a septic tank and is pumped via lift station to a leachfield. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order No. 86-203.
  
- f. **WOODBIDGE PARTNERS INC., VICTOR FINE FOODS FACILITY, LODI, SAN JOAQUIN COUNTY.** Waste Discharge Requirements Order (WDRs) No. 5-01-057, adopted 16 March 2001, prescribes requirements for closure of a lined Class II surface impoundment, an unlined surface impoundment, and a deep injection well at the former Victor Fine Foods facility in Lodi, San Joaquin County. The Discharger closed the impoundments by removing the liner from the Class II impoundment, filling both of the impoundments with clean soil, installing a low hydraulic conductivity soil layer and vegetative soil layer final cover over both areas, and grading them to drain. The injection well was also abandoned in compliance with local and federal regulations. The Discharger placed an approved Covenant and Environmental Restriction on the property restricting future development without review and approval by the Central Valley Water Board due to salt constituents remaining in soil beneath the former pond bottoms. There are no further industrial operations at the site and there is no significant continuing threat to water quality from the former impoundments. Therefore, WDRs are no longer necessary and Order No. 5-01-057 should be rescinded. (RDA)

IT IS HEREBY ORDERED that the above NPDES and WDR orders are rescinded.
