

CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD  
CENTRAL VALLEY REGION

ORDER NO. R5-2014-0141

The California Regional Water Quality Control Board, Central Valley Region (Central Valley Water Board), finds that the Central Valley Water Board adopted the following Orders which are no longer applicable for the reasons shown:

- a. **ALMANOR LAKESIDE VILLAS, PLUMAS COUNTY (FACILITY)**  
Waste Discharge Requirements Order No. 5-00-014, adopted on 28 January 2000, prescribes requirements for the discharge from Almanor Lakeside Villas, Plumas County (Facility). The Facility consists of a wastewater collection system and lift station discharging to leach fields. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order No. 5-00-014.
- b. **DEVIL'S GARDEN CONSERVATION CAMP, MODOC COUNTY (FACILITY)**  
Waste Discharge Requirements Order No. 91-231, adopted on 22 November 1991, prescribes requirements for the discharge from Devil's Garden Conservation Camp, Modoc County (Facility). The Facility consists of a wastewater collection system and septic tanks discharging to evaporation ponds and spray fields. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order No. 91-231.
- c. **FRESNO COUNTY WATERWORKS DISTRICT NO. 40, SHAVER SPRINGS WASTEWATER TREATMENT FACILITY, FRESNO COUNTY.** Waste Discharge Requirements Order 83-010, adopted on 28 January 1983, prescribes requirements for the discharge from the Shaver Springs Wastewater Treatment Facility in Fresno County. Fresno County Waterworks District No. 40 applied for coverage under Water Quality Order 97-10-DWQ, and a Notice of Applicability was issued on 4 September 2014. Therefore, WDRs Order 83-010 is no longer necessary and should be rescinded.
- d. **HAWES RIVER ACRES, INC., SHASTA COUNTY (FACILITY)**  
Wastewater Reclamation Requirements Order No. 88-171, adopted on 23 September 1988, prescribes requirements for the discharge of treated wastewater to the property of Hawes River Acres, Inc., Shasta County (Facility). The Facility consists of pasture with vernal pools that would receive discharge for two months of the year. The Facility is not operational, with no intention of future operations in the manner described by the Wastewater Reclamation Requirements Order No. 88-171. Therefore, it is appropriate to rescind Wastewater Reclamation Requirements Order No. 88-171.
- e. **J.F. SHEA CONSTRUCTION, INC., DBA FAWNDALE ROCK & ASPHALT (FACILITY)**  
Waste Discharge Requirements Order R5-2007-0137 (NPDES No. CA0083097), adopted on 26 October 2007, prescribes requirements for the discharge from J.F. Shea Construction, Inc., dba Fawndale Rock & Asphalt (Facility). The Facility discharges industrial storm water to West Fork of Stillwater Creek, Shasta County. All future storm water discharges will be covered under the Industrial General Permit Order No. 97-03-DWQ. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2007-0137.
- f. **INTER-MOUNTAIN FAIR OF SHASTA COUNTY (FACILITY)**  
Waste Discharge Requirements Order No. 94-044, adopted on 25 February 1994, prescribes requirements for the discharge from Inter-Mountain Fair of Shasta County (Facility). The Facility

consists of a wastewater collection system and lift station discharging to evaporation/percolation ponds. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order No. 94-044.

g. **LEHIGH SOUTHWEST CEMENT COMPANY (FACILITY)**

Waste Discharge Requirements Order R5-2007-0168 (NPDES No. CA0081191), adopted on 6 December 2007, prescribes requirements for the discharge from Lehigh Southwest Cement Company (Facility). The Facility discharges industrial storm water to West Fork of Stillwater Creek, Shasta County. All future storm water discharges will be covered under the Industrial General Permit Order No. 97-03-DWQ. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2007-0168.

h. **LIME SADDLE CAMPGROUND, BUTTE COUNTY (FACILITY)**

Waste Discharge Requirements Order No. 5-00-130, adopted on 28 January 2000, prescribes requirements for the discharge from Lime Saddle Campground, Butte County (Facility). The Facility is owned by DWR & operated by CSP and consists of a wastewater collection system and lift station discharging to leach fields. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order 5-00-130.

i. **STATE OF CALIFORNIA DEPARTMENT OF PARKS AND RECREATION, WOODSON BRIDGE STATE RECREATION AREA, TEHAMA COUNTY (FACILITY)**

Waste Discharge Requirements Order No. 86-113, adopted on 30 May 1986, prescribes requirements for the discharge from the State of California Department of Parks and Recreation, Woodson Bridge State Recreation Area, Tehama County (Facility). The Facility consists of an entrance station kiosk, and three day-use-only comfort stations, one with a shower facility. Wastewater discharges from a 1,500 gallon septic tank for the entrance office kiosk, a 3,700 gallon septic tank from the day use restroom/shower facility, and one of two 2,000 gallon septic tanks for restroom #1 and #3 and is pumped to separate leach field systems. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order No. 86-113.

j. **STIMPEL WIELBELHAUS ASSOCIATES, INC., DBA SWA AT MOUNTAIN GATE QUARRY, SHASTA COUNTY.**

Waste Discharge Requirements Order R5-2008-0120 (NPDES No. CA0084140), adopted on 31 July 2008, prescribes requirements for the discharge from Stimpel Wiebelhaus Associates, Inc., dba SWA at Mountain Gate Quarry (Facility). The Facility discharges industrial storm water to West Fork of Stillwater Creek, Shasta County. All future storm water discharges will be covered under the Industrial General Permit Order No. 97-03-DWQ. Therefore, it is appropriate to rescind Waste Discharge Requirements Order R5-2008-0120.

k. **UNIVAR USA INC. IN-SITU GROUNDWATER BIOREMEDIATION PROJECT, 1152 G STREET, FRESNO, FRESNO COUNTY.**

Waste Discharge Requirements Order R5-2013-0014, adopted on 1 February 2013, prescribes requirements for a groundwater cleanup system at the subject site. The cleanup involved injection of alcohol and/or other approved constituents to treat tetrachloroethene in groundwater. The system to be regulated under the order was never operated. In a letter dated 28 July 2014, the Discharger stated that it plans to switch to injection of potassium permanganate and will apply for coverage under General Order R5-2008-0149. The General Order regulates in-situ remediation at sites with volatile organic constituents. It is therefore appropriate to rescind WDR Order R5-2013-0014.

**I. VALLEY VIEW CONSERVATION CAMP, GLENN COUNTY (FACILITY)**


Waste Discharge Requirements Order No. 94-228, adopted on 5 August 1994, prescribes requirements for the discharge from Valley View Conservation Camp, Glenn County (Facility). The Facility consists of a wastewater collection system and septic tanks discharging to ponds and spray fields. The Facility is now regulated under General Order 97-10-DWQ (General Order) for discharges to land from small domestic systems with a maximum average daily flow of 20,000 gallons or less. Therefore, it is appropriate to rescind Waste Discharge Requirements Order No. 94-228.

**m. WENTWORTH WELLINGTON AND U.S. FOREST SERVICE, TAHOE NATIONAL FOREST**

Waste Discharge Requirements Order 88-103 adopted on 24 June 1988 prescribes waste discharge requirements for the discharge of mining waste to land and process ponds at the Deep Moon Gold Mine (also known as the Freedom Moon Gold Mine) in Sierra County. Wentworth Wellington (owner/operator of the Deep Moon Gold Mine) and the United States Forest Service, Tahoe National Forest (land manager) are identified as the Dischargers. In 2008, Forest Service staff notified Central Valley Water Board staff that Mr. Wellington passed away in the early 2000's. The Forest Service stated there will be no further discharge of mining waste and that they have developed stabilization and reclamation measures to ensure that the site will not pose a threat to water quality. Post-closure monitoring is not necessary. Because the mine is no longer in operation, it is appropriate to rescind WDRs Order 88-103

IT IS HEREBY ORDERED that the above Orders are rescinded.
