NOTICE TENTATIVE WASTE DISCHARGE REQUIREMENTS FOR TUOLUMNE UTILITIES DISTRICT SONORA REGIONAL WASTEWATER TREATMENT FACILITY TUOLUMNE COUNTY

TO ALL CONCERNED PERSONS AND AGENCIES

Enclosed are tentative Waste Discharge Requirements (TWDRs) and tentative Monitoring and Reporting Program (MRP) for the Tuolumne Utilities District's (TUD or Discharger) Sonora Regional Wastewater Treatment Facility (WWTF). The Central Valley Regional Water Quality Control Board (or Central Valley Water Board) will consider adopting the TWDRs at its 18/19 April 2024 Board Meeting. Any written comments or evidence you may have concerning these items must be submitted to this office by **5:00 pm on 2 February 2024**. Absent a showing of good cause and lack of prejudice to other parties, the Board Chair may exclude comments and evidence received after this deadline.

To conserve paper and reduce mailing costs, a paper copy of these items has been sent only to the Discharger.
