BLYTHE MESA SOLAR II PROJECT**

The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment proposed Order R7-2020-0047 (Proposed Order) to Blythe Mesa Solar II, LLC (Permittee) for the Blythe Mesa Solar II Project (Project). The Project site is located in east Riverside County, approximately five miles west of central Blythe and 40 miles east of Desert Center; more specifically, the Project is located north and south of Interstate 10 (I-10), west of Neighbors Boulevard and Arrowhead Boulevard, and south and east of the Blythe Airport.. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
