The California Regional Water Quality Control Board, Colorado River Basin Region (Colorado River Basin Water Board) is releasing for public review and comment Proposed Order R7-2022-0004 to Desert Quartzite, LLC for the Desert Quartzite Solar Project. Desert Quartzite, LLC is proposing to construct, operate, maintain, and decommission a solar energy production facility on 2,953 acres of land in Riverside County, approximately 2.75 miles southwest of the City of Blythe. The facility will be constructed primarily on land managed by the U.S. Bureau of Land Management. The Project is expected to impact waters of the state.

The Colorado River Basin Water Board intends to consider adopting the Proposed Order during a public hearing that will commence at the time and place indicated:
