I. Order

This Clean Water Act (CWA) section 401 Water Quality Certification action and Order (Order) is issued at the request of Coachella Valley Water District (Permittee or CVWD) for the CVSC Improvement Project: Avenue 54 to Thermal Drop Structure (Project). This Order is for the purpose described in the application submitted by the Permittee. The application was received on October 17, 2019. The application was deemed complete on March 9, 2020. Prior to receiving a complete application, Colorado River Basin Water Board Staff issued notices of incomplete application on December 9, 2019 and January 15, 2020. The Permittee responded to the request for application information on December 11, 2019 and February 7, 2020.

II. Public Notice

The Colorado River Basin Water Board provided public notice of the application pursuant to California Code of Regulations, title 23, section 3858 from November 6, 2019 to November 26, 2019. The Colorado River Basin Water Board did not receive any comments during the comment period.

III. Project Purpose

The purpose of the Project is to increase the capacity of the Coachella Valley Stormwater Channel (CVSC) to contain stormwater from a 100-year flood storm event.

IV. Project Description

The Permittee proposes to line the banks of roughly 5,000 feet of the CVSC, leaving a soft bottom in the majority of the channel. The Project includes numerous components, including relocations of a lateral drain, power line, natural gas line, and power pole. The channel bottom under four bridges (Highway 111, North Union Pacific Railroad (UPRR), South UPRR, and Airport Boulevard) will require concrete lining for scour protection. The Thermal Drop Structure will be removed completely from the channel. Channel vegetation will continue to be maintained as is standard practice for CVWD.

Fully Lined Portions

The channel portions beneath crossing bridges will be fully lined to create scour protection. The bridges at Airport Boulevard, Highway 111, North and South UPRR crossings will all require concrete on the banks and the channel bottom.

Irrigation Lateral Relocation

An irrigation lateral that runs from the western to eastern sides of the CVSC will be relocated approximately 75 feet north of its current position. The existing lateral will connect to the new extension by a 72-inch pipe casing.

Gas Line Relocation

Southern California Gas Company has an 8-inch natural gas pipeline buried in the CVSC right-of-way that will need to be relocated. The pipe is approximately 30 feet downstream

of the Highway 111 Bridge. The new pipe will be placed deeper than the existing pipe and below the channel lining. The drill rig to bore for the pipe will be located near Highway 111 and the staging area will be in the right-of-way. Drilling will occur in a southeasterly direction parallel to Highway 111. At the exit, Southern California Gas Company will stage the replacement pipeline, approximately 1,500 feet long, and it will be attached to the drill rig to be run through the bore hole to the existing line for joining. The existing pipe will be removed within the channel and the remaining pipe will be abandoned in place.

Power Pole Relocation

Imperial Irrigation District (IID) has a power line that crosses the CVSC within the Project area. The power line is supported by three wooden poles, one to the east and west of the channel and one in the center. Two of the poles, the pole within the channel and the one to the west will need to be removed. The poles to the east and west of the channel will be replaced with new wooden poles to support the line crossing the CVSC. The pole in the center of the channel will not be replaced.

Power Line Relocation

An IID power line runs near the irrigation lateral that is to be relocated as part of this Project and will also need to be relocated to be outside of the Project area. The line will continue in the same direction; three existing wooden poles will be removed and replaced with two wooden poles. One additional wooden pole north of the new poles will also be replaced in kind.

V. Project Location

The Project site is located near Thermal in Riverside County, California. The Project is within the CVSC from approximately 130 feet north of Avenue 54 to approximately 300 feet south of the Thermal Drop Structure (between Avenues 57 and 58). Township/Range: T6S R8E Sections 15, 22, 27 (Latitude 33° 38' 54.1", Longitude -116° 08' 27.1"). Maps showing the Project location are found in Attachment A of this Order.

VI. Project Impact and Receiving Waters Information

The Project is located within the jurisdiction of Colorado River Basin Water Board. Receiving waters and groundwater potentially impacted by the Project are protected in accordance with the Water Quality Control Plan for the Colorado River Basin Region (<u>Basin Plan</u>) and other plans and policies, which may be accessed online at: <u>https://www.waterboards.ca.gov/plans_policies/</u>. The Basin Plan includes water quality standards, which consist of existing and potential beneficial uses of waters of the U.S./state, water quality objectives to protect those uses, and the state and federal antidegradation policies.

Further Project impact and receiving waters information can be found in Attachment B.

Table 1 of Attachment B shows the receiving waters and beneficial uses of waters of the U.S./state impacted by the Project. Individual impact location and quantity is shown in Table 2 of Attachment B.

VII. Description of Direct Impacts to Waters of the State/U.S.

The Project will take place entirely within the Coachella Valley Stormwater Channel. Roughly 5,000 feet of the channel sides will be lined with concrete. Most of the area will be left as a soft bottom with small portions concrete lined under bridges to prevent scour.

Total Project fill/excavation quantities for all impacts are summarized in Table 1. Permanent impacts are categorized as those resulting in a physical loss in area and also those degrading ecological conditions only.

VIII. Compensatory Mitigation

The Permittee has agreed to provide compensatory mitigation for direct permanent impacts to waters at a 1:1 ratio. The Permittee proposes to create 9.54 acres of wetlands suitable for California black rail and Yuma clapper rail habitat near the north shore of the Salton Sea at the Garfield Street Site. This mitigation is part of a larger mitigation effort by the Permittee to address all activities within the CVSC in cooperation with the Coachella Valley Multiple Species Habitat Conservation Plan.

IX. California Environmental Quality Act (CEQA)

On October 30, 2019, CVWD, as lead agency, certified a Final Environmental Impact Report (FEIR) (State Clearinghouse [SCH] No. 2015111067) for the Project and filed a Notice of Determination (NOD) at the SCH on November 18, 2019. As a responsible agency, the Colorado River Basin Water Board has reviewed and considered the environmental documents prepared by the CVWD and finds that they address the Project's water resource impacts. (Cal. Code Regs., tit. 14, § 15096, subd. (f).) Pursuant to CEQA, the Colorado River Basin Water Board has made Findings of Facts (Findings) supporting the issuance of this Order in Attachment C.

¹ Includes only temporary direct impacts to waters of the state/U.S. and does not include upland areas of temporary disturbance which could result in a discharge to waters of the state/U.S. Temporary impacts, by definition, are restored to pre-project conditions and therefore do not include a physical loss of area or degradation of ecological condition.

X. Petitions for Reconsideration

Any person aggrieved by this action may petition the State Water Resources Control Board (State Water Board) to reconsider this Order in accordance with California Code of Regulations, title 23, section 3867. A petition for reconsideration must be submitted in writing and received within 30 calendar days of the issuance of this Order.

XI. Fees Received

An application fee of \$1,638 was received on October 14, 2019. The fee amount was determined as required by California Code of Regulations, title 23, sections 3833(b)(3) and 2200(a)(3), and was calculated as category A - Fill & Excavation Discharges (fee code 84) with the dredge and fill fee calculator. The project fee of \$140,462 based on total Project impacts was received on October 16, 2020.

XII. Conditions

The Colorado River Basin Water Board has independently reviewed the record of the Project to analyze impacts to water quality and designated beneficial uses within the watershed of the Project. In accordance with this Order, the Permittee may proceed with the Project under the following terms and conditions:

A. Authorization

Impacts to waters of the U.S./state shall not exceed quantities shown in Table 1.

B. Reporting and Notification Requirements

The following section details the reporting and notification types and timing of submittals. Requirements for the content of these reporting and notification types are detailed in Attachment E, including specifications for photo and map documentation during the Project.

Written reports and notifications must be submitted using the Reporting and Notification Cover Sheet located in Attachment E, which must be signed by the Permittee or an authorized representative.

1. Project Reporting

- a. **Monthly Reporting:** The Permittee must submit a Monthly Report to the Colorado River Basin Water Board on the 15th day of each month for the duration of the construction phase. Monthly reporting shall continue until the Colorado River Basin Water Board issues a Notice of Project Complete Letter to the Permittee.
- b. Annual Reporting: The Permittee must submit an Annual Report including activities conducted for the previous fiscal year (July 1-June 30) to the Colorado River Basin Water Board on the 1st of September. Annual Reports must be submitted even if Project construction has not begun. Annual

reporting shall continue until a Notice of Project Complete Letter is issued to the Permittee by the Colorado River Basin Water Board.

c. **Other Reporting:** If pollutants are observed in surface water, the Permittee shall submit a report to the Colorado River Basin Water Board within 30 days after encountering the pollutants and describe actions taken to correct the problem and provide photographic documentation that supports the information in the report.

If repairs are required, the Permittee shall take pictures of the area where work needs to take place, documenting the before and after conditions of the area; and shall maintain a daily log for each site where work is taking place pursuant to this Order, while the Permittee conducts its repair activities. The log shall:

- Provide a general description of the repair work;
- Specify the date and daily starting and ending time for the repair work;
- Note key weather conditions (e.g., temperature, wind speed and direction, precipitation, if any);
- Include notes from visual observations regarding the presence/absence of construction debris/trash (e.g., discarded filter fiber) and used oil (e.g., oil that leaks from construction equipment) in the area where the work has taken place.

Within 30 days following completion of all repair work, the Permittee shall submit to the Colorado River Basin Water Board a summary report of the key daily log entries. The summary report shall include the abovementioned before and after pictures of the conditions of the area and shall be signed by the Permittee's Project Manager.

2. Project Status Notifications

- **a. Commencement of Construction:** The Permittee shall submit a Commencement of Construction Report at least seven (7) days prior to start of initial ground disturbance activities.
- b. Request for Notice of Completion of Discharges Letter: The Permittee shall submit a Request for Notice of Completion of Discharges Letter following completion of active Project construction activities, including any required restoration and permittee-responsible mitigation. This request shall be submitted to the Colorado River Basin Water Board staff within 30 days following completion of all Project construction activities. Upon acceptance of the request, Colorado River Basin Water Board staff will issue a Notice of Completion of

Discharges Letter to the Permittee which will end the active discharge period and associated annual fees.

c. Request for Notice of Project Complete Letter: The Permittee shall submit a Request for Notice of Project Complete Letter when construction and/or any post-construction monitoring is complete,² and no further Project activities will occur. This request shall be submitted to Colorado River Basin Water Board staff within 30 days following completion of all Project activities. Upon approval of the request, the Colorado River Basin Water Board staff shall issue a Notice of Project Complete Letter to the Permittee which will end the post discharge monitoring period and associated annual fees.

3. Conditional Notifications and Reports:

The following notifications and reports are required as appropriate.

- a. Accidental Discharges of Hazardous Materials³: Following an accidental discharge of a reportable quantity of a hazardous material, sewage, or an unknown material, the following applies (Wat. Code, § 13271):
 - i. As soon as (A) the Permittee has knowledge of the discharge or noncompliance, (B) notification is possible, and (C) notification can be provided without substantially impeding cleanup or other emergency measures, then:
 - first call 911 (to notify local response agency)
 - then call Office of Emergency Services (OES) State Warning Center at:
 - (800) 852-7550 or (916) 845-8911
 - Lastly, follow the required OES procedures as set forth in: <u>http://www.caloes.ca.gov/FireRescueSite/Documents/CalOES-Spill_Booklet_Feb2014_FINAL_BW_Acc.pdf</u>
 - Following notification to OES, the Permittee shall notify the Colorado River Basin Water Board, as soon as practicable (ideally within 24 hours). Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.

² Completion of post-construction monitoring shall be determined by Colorado River Basin Water Board staff and shall be contingent on successful attainment of restoration and mitigation performance criteria.

³ "Hazardous material" means any material that, because of its quantity, concentration, or physical or chemical characteristics, poses a significant present or potential hazard to human health and safety or to the environment if released into the workplace or the environment. "Hazardous materials" include, but are not limited to, hazardous substances, hazardous waste, and any material that a handler or the administering agency has a reasonable basis for believing that it would be injurious to the health and safety of persons or harmful to the environment if released into the workplace or the environment. (Health & Saf. Code, § 25501.)

- iii. Within five (5) working days of notification to the Colorado River Basin Water Board, the Permittee must submit an Accidental Discharge of Hazardous Material Report.
- **b.** Violation of Compliance with Water Quality Standards: The Permittee shall notify the Colorado River Basin Water Board of any event causing a violation of compliance with water quality standards. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
 - i. Examples of noncompliance events include lack of storm water treatment following a rain event, discharges causing a visible plume in a water of the state/U.S., and runoff from water contact with uncured concrete.
 - **ii.** This notification must be followed within three (3) working days by submission of a Violation of Compliance with Water Quality Standards Report.

c. In-Water Work:

- i. The Permittee shall notify the Colorado River Basin Water Board at least 48 hours prior to initiating work in water or stream diversions. Notification may be via telephone, e-mail, delivered written notice, or other verifiable means.
- **ii.** Within three (3) working days following completion of work in water or stream diversions, an In-Water Work/Diversions Water Quality Monitoring Report must be submitted to Colorado River Basin Water Board staff.
- d. Modifications to Project: Project modifications may require an amendment of this Order. The Permittee shall give advance notice to Colorado River Basin Water Board staff if Project implementation as described in the application materials is altered in any way or by the imposition of subsequent permit conditions by any local, state or federal regulatory authority by submitting a Modifications to Project Report. The Permittee shall inform Colorado River Basin Water Board staff of any Project modifications that will interfere with the Permittee's compliance with this Order.
- e. Transfer of Property Ownership: This Order is not transferable in its entirety or in part to any person or organization except after notice to the Colorado River Basin Water Board in accordance with the following terms:
 - i. The Permittee must notify the Colorado River Basin Water Board of any change in ownership or interest in ownership of the Project area by submitting a Transfer of Property Ownership Report. The Permittee and purchaser must sign and date the notification and provide such

notification to the Colorado River Basin Water Board at least 10 days prior to the transfer of ownership.

- **ii.** Until such time as this Order has been modified to name the purchaser as the permittee, the Permittee shall continue to be responsible for all requirements set forth in this Order.
- f. Transfer of Long-Term BMP Maintenance: If maintenance responsibility for post-construction best management practices (BMPs) is legally transferred, the Permittee must submit to the Colorado River Basin Water Board a copy of such documentation and must provide the transferee with a copy of a long-term BMP maintenance plan that complies with manufacturer or designer specifications. The Permittee must provide such notification to the Colorado River Basin Water Board with a Transfer of Long-Term BMP Maintenance Report at least 10 days prior to the transfer of BMP maintenance responsibility.

C. Water Quality Monitoring

- 1. General: If surface water is present, continuous visual surface water monitoring shall be conducted to detect accidental discharge of construction related pollutants (e.g. oil and grease, turbidity plume, or uncured concrete).
- 2. Accidental Discharges/Noncompliance: Upon occurrence of an accidental discharge of hazardous materials or a violation of compliance with a water quality standard, Colorado River Basin Water Board staff may require water quality monitoring based on the discharge constituents and/or related water quality objectives and beneficial uses.
- **3. In-Water Work or Diversions:** For projects involving planned work in water or stream diversions, a water quality monitoring plan shall be submitted to Colorado River Basin Water Board staff for acceptance at least 30 days in advance of any discharge to the affected water body. Water quality monitoring shall be conducted in accordance with the approved plan.

Sampling shall be conducted in accordance with Table 2 sampling parameters.⁴

⁴ Pollutants shall be analyzed using the analytical methods described in 40 Code of Federal Regulations part 136; where no methods are specified for a given pollutant, the method shall be approved by Colorado River Basin Water Board's Executive Officer. Grab samples shall be taken between the surface and mid-depth and not be collected at the same time each day to get a complete representation of variations in the receiving water. A hand-held field meter may be used, provided the meter utilizes a U.S. EPA-approved algorithm/method and is calibrated and maintained in accordance with the manufacturer's instructions. A calibration and maintenance log for each meter used for monitoring shall be maintained onsite.

4. Post-Construction: The Permittee shall visually inspect the Project site during the rainy season for five (5) years to ensure excessive erosion, stream instability, or other water quality pollution is not occurring in or downstream of the Project site. If water quality pollution is occurring, the Permittee shall contact the Colorado River Basin Water Board staff member overseeing the Project within three (3) working days. The Colorado River Basin Water Board Nater Board may require the submission of a Violation of Compliance with Water Quality Standards Report. Additional permits may be required to carry out any necessary site remediation.

D. Standard

- 1. This Order is subject to modification or revocation upon administrative or judicial review, including review and amendment pursuant to Water Code section 13330, and California Code of Regulations, title 23, chapter 28, article 6 commencing with section 3867. Additionally, the Colorado River Basin Water Board reserves the right to suspend, cancel, or modify and reissue this Order, after providing notice to the Permittee, if the Colorado River Basin Water Board determines that: the Project fails to comply with any of the conditions of this Order; or, when necessary to implement any new or revised water quality standards and implementation plans adopted or approved pursuant to the Porter-Cologne Water Quality Control Act (Wat. Code, § 13000 et seq.) or federal Clean Water Act section 303 (33 U.S.C. § 1313). For purposes of Clean Water Act section 401(d), the condition constitutes a limitation necessary to ensure compliance with water quality standards and appropriate requirements of state law.
- 2. This Order is not intended and shall not be construed to apply to any activity involving a hydroelectric facility requiring a Federal Energy Regulatory Commission (FERC) license or an amendment to a FERC license, unless the pertinent certification application was filed pursuant to subsection 3855(b) of chapter 28, title

⁵ Waters shall be free of changes in turbidity that cause nuisance or adversely affect beneficial uses.

⁶ The natural receiving water temperature of surface waters shall not be altered by discharges of waste unless it can be demonstrated to the satisfaction of the Regional Water Board that such alteration in temperature does not adversely affect beneficial uses.

23 of the California Code of Regulations, and that application specifically identified that a FERC license or amendment to a FERC license for a hydroelectric facility was being sought.

- 3. This Order is conditioned upon total payment of any fee required under title 23 of the California Code of Regulations and owed by the Permittee.
- 4. In the event of any violation or threatened violation of the conditions of this Order, the violation or threatened violation shall be subject to any remedies, penalties, process, or sanctions as provided for under state and federal law. For purposes of Clean Water Act section 401(d), the applicability of any state law authorizing remedies, penalties, processes, or sanctions for the violation or threatened violation constitutes a limitation necessary to ensure compliance with the water quality standards and other pertinent requirements incorporated into this Order.

E. General Compliance

- 1. Failure to comply with any condition of this Order shall constitute a violation of the Porter-Cologne Water Quality Control Act and the Clean Water Act. The Permittee and/or discharger may then be subject to administrative and/or civil liability pursuant to Water Code section 13385.
- 2. Permitted actions must not cause a violation of any applicable water quality standards, including impairment of designated beneficial uses for receiving waters as adopted in the Basin Plan by the Colorado River Basin Water Board or any applicable State Water Board water quality control plan or policy. The source of any such discharge must be eliminated as soon as practicable.
- **3.** In response to a suspected violation of any condition of this Order, the Colorado River Basin Water Board may require the holder of this Order to furnish, under penalty of perjury, any technical or monitoring reports the Water Boards deem appropriate, provided that the burden, including costs, of the reports shall bear a reasonable relationship to the need for the reports and the benefits to be obtained from the reports. Additional monitoring requirements ensure that permitted discharges and activities comport with any applicable effluent limitations, water quality standards, and/or other appropriate requirement of state law.
- **4.** The Permittee must, at all times, fully comply with engineering plans, specifications, and technical reports submitted to support this Order; and all subsequent submittals required as part of this Order. The conditions within this Order and Attachments supersede conflicting provisions within Permittee submittals.
- **5.** This Order and all of its conditions contained herein continue to have full force and effect regardless of the expiration or revocation of any federal license or permit issued for the Project. For purposes of Clean Water Act section 401(d), this

condition constitutes a limitation necessary to ensure compliance with the water quality standards and other pertinent requirements of state law.

- **6.** The Permittee shall adhere to all requirements in the Mitigation Monitoring and Reporting Program (MMRP) of the FEIR, which is incorporated by reference and any additional measures outlined in Attachment C, CEQA Findings of Fact.
- Construction General Permit Requirement: The Permittee shall maintain compliance with conditions described in, and required by, National Pollutant Discharge Elimination System (NPDES) General Permit for Storm Water Discharges Associated with Construction and Land Disturbance Activities (Order No. 2009-0009-DWQ; NPDES No. CAS000002).

F. Administrative

- **1.** Signatory requirements for all document submittals required by this Order are presented in Attachment D of this Order.
- 2. This Order does not authorize any act which results in the taking of a threatened, endangered or candidate species or any act, which is now prohibited, or becomes prohibited in the future, under either the California Endangered Species Act (Fish & G. Code, §§ 2050-2097) or the federal Endangered Species Act (16 U.S.C. §§ 1531-1544). If a "take" will result from any act authorized under this Order held by the Permittee, the Permittee must obtain authorization for the take prior to any construction or operation of the portion of the Project that may result in a take. The Permittee is responsible for meeting all requirements of the applicable endangered species act for the Project authorized under this Order.
- **3.** The Permittee shall grant Colorado River Basin Water Board staff or an authorized representative (including an authorized contractor acting as a Water Board representative), upon presentation of credentials and other documents as may be required by law, permission to:
 - **a.** Enter upon the Project or compensatory mitigation site(s) premises where a regulated facility or activity is located or conducted, or where records are kept.
 - **b.** Have access to and copy any records that are kept and are relevant to the Project or the requirements of this Order.
 - **c.** Inspect any facilities, equipment (including monitoring and control equipment), practices, or operations regulated or required under this Order.
 - **d.** Sample or monitor for the purposes of assuring Order compliance.
- **4.** A copy of this Order shall be provided to any consultants, contractors, and subcontractors working on the Project. Copies of this Order shall remain at the

Project site for the duration of this Order. The Permittee shall be responsible for work conducted by its consultants, contractors, and any subcontractors.

- **5.** A copy of this Order must be available at the Project site(s) during construction for review by site personnel and agencies. All personnel performing work on the Project shall be familiar with the content of this Order and its posted location at the Project site.
- 6. Lake and Streambed Alteration Agreement The Permittee shall submit a signed copy of the Department of Fish and Wildlife's lake and streambed alteration agreement to the Colorado River Basin Water Board immediately upon execution and prior to any discharge to waters of the state/U.S.

G. Construction

Good Site Management "Housekeeping"

- 1. The Permittee shall follow good site management "housekeeping" and implement erosion control, sediment control, and other construction-related best management practices (BMPs) depicted in Table 3 below.
- 2. A qualified biological monitor shall be on site during all ground-disturbing activities (work area preparation, grading, clearing, grubbing, trenching, construction, and decommissioning activities) to prevent impacts to special-status species and other biological resources, as well as document and report any construction-related incidences.
- **3.** The area of vegetation and soil disturbance shall be restricted to the smallest extent possible.
- **4.** After completing construction activities, any disturbed areas shall be restored to pre-existing contours and conditions to the extent feasible.

- **5.** No toxic and/or hazardous materials shall be stored near or within wash/drainage areas. To the extent practicable, these materials shall be stored offsite and placed in appropriate secondary containment.
- 6. Spoil sites shall not be located where spoil could be washed back into the stream channel or where spoil covers aquatic or riparian vegetation. Any materials placed in seasonally dry portions of the drainage areas that could be washed downstream or could be harmful to aquatic life shall be removed from the streambed prior to inundation by high flows.
- **7.** No fueling or maintenance of equipment or vehicles shall occur adjacent or within the wash/drainage areas.

Roads

8. Work and staging areas and temporary access routes shall be sized, located, and flagged to limit potential impacts to natural areas. Previously-disturbed areas shall be used to the extent feasible.

Sediment Control

- **9.** The Permittee shall implement sediment control BMPs to remove sediment loads from runoff generated within the construction site for all disturbed areas. Examples: silt fence, fiber rolls, gravel bags, dewatering filtration.
- **10.** The Permittee shall implement off-site sediment tracking control BMPs for reducing the transport of sediment on tires off of and within the construction site. Examples: stabilized construction entrance/exit tire wash, entrance/exit inspection and cleaning facility.

Stabilization/Erosion Control

11. The Permittee shall implement erosion control BMPs to mitigate soil erosion, minimize soil loss from wind erosion, and to reduce air pollution during construction activities for all disturbed areas. Examples: mulch, straw, wood chips, soil application, lot perimeter protection per county standards, bonded fiber matrix or stabilized fiber matrix, physical stabilization erosion control blanket.

Stormwater

- **12.**Work shall not be conducted during rain events.
- **13.** The Permittee shall develop and implement a Stormwater Pollution Prevention Plan (SWPPP) that complies with the requirements of the State Water Board's Construction General Permit.

- **14.** Post-construction, the Permittee shall implement channel protection BMPs to protect banks of the channels as well as the slopes.
- **15.** Post-construction, the Permittee shall implement outlet protection BMPs to reduce discharge/water velocity. Examples: energy dissipater outlet protection, velocity dissipation devices.

H. Mitigation for Temporary Impacts

- 1. The Permittee shall restore all areas of temporary impacts to waters of the U.S./state and all Project site upland areas of temporary disturbance which could result in a discharge to waters of the U.S./state.
- 2. The Colorado River Basin Water Board may extend the monitoring period beyond requirements of the restoration plan upon a determination by Colorado River Basin Water Board staff that the performance standards have not been met or are not likely to be met within the monitoring period.

I. Compensatory Mitigation for Permanent Impacts⁷

1. Total Required Compensatory Mitigation

- **a.** The Permittee is required to provide compensatory mitigation at a 1:1 ratio for authorized permanent impacts to 9.45 acres of stream channel by creating wetlands suitable for California black rail and Yuma clapper rail habitat.
- **b.** Total required, Project-compensatory mitigation information for permanent physical loss of area is summarized in Table 4:

2. Final Compensatory Mitigation Plan

- a. The Permittee provided compensatory mitigation for impacts to waters of the state in accordance with Garfield Street and Johnson Street Constructed Habitat Projects Work Plan (Compensatory Mitigation Plan) dated April 22, 2020 and incorporated herein by reference. Any deviations from, or revisions to, the Compensatory Mitigation Plan must be pre-approved by Colorado River Basin Water Board staff. The monitoring period shall continue until the Colorado River Basin Water Board staff determines that performance standards have been met. This may require the monitoring period to be extended.
- b. The final compensatory mitigation plan shall include all plan elements as outlined in the State Wetland Definition and Procedures for Discharges of Dredged or Fill Material to Waters of the State and the State Supplemental Dredge or Fill Guidelines, Subpart J – Compensatory Mitigation for Losses of Aquatic Resources.

3. Permittee-Responsible Compensatory Mitigation Responsibility

- **a.** The Permittee shall provide updates in the Annual Report concerning the progress of the Permittee-responsible compensatory mitigation installation.
- **b.** The Permittee is responsible for the required compensatory mitigation in perpetuity. However, the Permittee may transfer the compensatory mitigation requirements associated with long-term management when the following conditions have been met:
 - i. Performance standards are met.
 - **ii.** A Transfer Agreement to a third party has been approved by Colorado River Basin Water Board staff.
 - **iii.** An endowment fund has been provided by the Permittee to a third party for management in perpetuity of the mitigation site.
 - **iv.** A conservation easement, deed restriction, or other appropriate restrictive covenant for the mitigation site has been recorded and approved by Colorado River Basin Water Board staff.
- **c.** Transfer of Long-Term Permittee-Responsible Compensatory Mitigation and Management Responsibility
 - i. A transfer agreement shall be submitted from an authorized representative of the new party (transferee) for acceptance by Colorado River Basin Water Board staff. This agreement shall demonstrate acceptance and understanding of the responsibility to comply with and

fully satisfy the required compensatory mitigation and long-term management conditions. Failure to comply with the mitigation conditions and associated requirements may subject the transferee to enforcement by the Colorado River Basin Water Board under Water Code section 13385, subdivision (a).

ii. Notification of transfer of responsibilities meeting the above condition must be provided to the Colorado River Basin Water Board staff. A draft transfer agreement is due to Colorado River Basin Water Board staff no less than 30 days prior to the transfer of the mitigation responsibility. A final transfer agreement is due to Colorado River Basin Water Board staff within 30 days of the completion of the transfer.

XIII. Water Quality Certification

I hereby issue the Order for the CVSC Improvement Project; Avenue 54 to Thermal Drop Structure, WDID NO: 7A333210001 certifying under Clean Water Act section 401 that as long as all of the conditions listed in this Order are met, any discharge from the referenced Project will comply with the applicable provisions of Clean Water Act sections 301 (Effluent Limitations), 302 (Water Quality Related Effluent Limitations), 303 (Water Quality Standards and Implementation Plans), 306 (National Standards of Performance), and 307 (Toxic and Pretreatment Effluent Standards). Pursuant to State Water Board Order No. 2003-0017-DWQ, this Order also serves as Waste Discharge Requirements (WDRs) under the Porter-Cologne Water Quality Control Act (Water Code, § 13000 et seq.).

Except insofar as may be modified by any preceding conditions, all Order actions are contingent on: (a) the discharge being limited and all proposed mitigation being completed in strict compliance with the conditions of this Order and the attachments to this Order; and, (b) compliance with all applicable requirements of statewide water quality control plans and policies and the Colorado River Basin Water Board's Basin Plan and policies.

Compensatory Mitigation Information

The Permittee is a signatory of the Coachella Valley Multiple Species Habitat Conservation Plan (CVMSHCP) and has agreed to create habitat for endangered species and contribute to the Endowment Fund to mitigate for projects within the Coachella Valley Stormwater Channel (CVSC). Two of the habitat projects are applicable mitigation for the Colorado River Basin Regional Board's purposes, as they create wetlands suitable for the California black rail/Yuma clapper rail habitat and desert

pupfish habitat. These two habitats are part of the Garfield Street Site mitigation project. The total amount of habitat created will mitigate several projects, hence this Project will only account for 9.45 acres of the 91 acres of total habitat. The remaining acreage will be available for future projects and accounted for by Colorado River Basin Regional Board staff to ensure no multiple use.

Attachment C CEQA Findings

A. Environmental Review

On October 30, 2019, the CVWD, as lead agency, certified a Final Environmental Impact Report (FEIR) (State Clearinghouse [SCH] No. 2015111067) for the Project and filed a Notice of Determination (NOD) at the SCH on November 18, 2019.

The Colorado River Basin Water Board is a responsible agency under CEQA (Pub. Resources Code, § 21069) and in making its determinations and findings, must presume that CVWD's certified environmental document comports with the requirements of CEQA and is valid. (Pub. Resources Code, § 21167.3.) The Colorado River Basin Water Board has reviewed and considered the environmental document and finds that the environmental document prepared by CVWD addresses the Project's water resource impacts. (Cal. Code Regs., tit. 14, § 15096, subd. (f).) The environmental document includes the mitigation monitoring and reporting program (MMRP) developed by CVWD for all mitigation measures that have been adopted for the Project to reduce potential significant impacts. (Pub. Resources Code, § 21081.6, subd. (a)(1); Cal. Code Regs., tit. 14, § 15091, subd. (d).)

B. Incorporation by Reference

Pursuant to CEQA, these Findings of Facts (Findings) support the issuance of this Order based on the FEIR, the application for this Order, and other supplemental documentation.

All CEQA project impacts are analyzed in detail in the FEIR, which is incorporated herein by reference and available at: <u>http://cvwd.org/447/CV-Stormwater-Channel-Improvement-Project</u>

Requirements under the purview of the Colorado River Basin Water Board in the MMRP are incorporated herein by reference.

The Permittee's application for this Order, including all supplemental information provided, is incorporated herein by reference.

C. Findings and Determination

Having considered the whole of the record, the Colorado River Basin Water Board has determined that there is no substantial evidence that the Project or any of its aspects could result in significant adverse impacts to water resources, when implemented in accordance with the mitigation measures required in MMRP and the conditions in this Order. (Cal. Code Regs., tit. 14, § 15096, subd. (h).)

The Colorado River Basin Water Board will file a NOD with the SCH within five (5) working days from the issuance of this Order. (Cal. Code Regs., tit. 14, §§ 15096, subd. (i).)
