**COMPLIANCE ORDER NO. 24-E1-23R-004
ADMINISTRATOR ORDER TO TEVISTON COMMUNITY SERVICES DISTRICT AND
SELECTION OF STANTEC CONSULTING SERVICES INC. AS THE FULL-SCOPE
ADMINISTRATOR**

Enclosed is Compliance Order No. 24-E1-23R-004 (Order), issued to the Teviston Community Services District (Teviston CSD) public water system. Please note that there are legally enforceable directives associated with this Order.

As discussed in the Order, Teviston CSD is ordered to accept Stantec Consulting Services Inc. (Stantec) as a full-scope administrator and allow Stantec to exercise full authority and control over Teviston CSD. The State Water Board looks forward to continuing to work with both Teviston CSD and Stantec as they develop a sustainable long-term solution.

Any person who is aggrieved by a citation, order or decision issued under authority delegated to an officer or employee of the State Board under Article 8 (commencing with CHSC, Section 116625) or Article 9 (commencing with CHSC, Section 116650), of the Safe Drinking Water Act (CHSC, Division 104, Part 12, Chapter 4), may file a petition with the State Board for reconsideration of the citation, order or decision.

Petitions must be received by the State Board within 30 days of the issuance of the citation, order or decision by the officer or employee of the State Board. The date of issuance is the date when the Division of Drinking Water signs the citation, order or decision. If the 30th day falls on a Saturday, Sunday, or state holiday, the petition is due the following business day by 5:00 p.m.
