**COMMENT PERIOD EXTENDED - REQUEST FOR SUPPORTING DOCUMENTATION AND COMMENT PERIOD EXTENSION FOR PROPOSED CLEANUP AND ABATEMENT ORDERS: LAKE TAHOE LAUNDRY WORKS, BIG O TIRES, AND FORMER NORMA'S CLEANERS, SOUTH LAKE TAHOE, EL DORADO COUNTY**

On June 22, 2022, Scott Reisch of Hogan Lovells, on behalf of Fox Capital Management Corporation (Fox), provided a letter by electronic mail which requested (1) copies of the supporting documents referenced in the proposed Cleanup and Abatement Order (CAO) for Lake Tahoe Laundry Works and (2) an extension to the comment period for proposed CAOs for Lake Tahoe Laundry Works, Big O Tires, and Former Norma's Cleaners to until the later of (a) September 19, 2022, and (b) 60 days from the date the Regional Board provides the additional documents.

On June 24, 2022, William Tarantino of Morrison Foerster, on behalf of Seven Springs Limited Partnership, provided a letter by electronic mail which requested (1) copies of the supporting documents referenced in the proposed Cleanup and Abatement Order (CAO) for Lake Tahoe Laundry Works and (2) an extension to the comment period for proposed CAOs for Lake Tahoe Laundry Works, Big O Tires, and Former Norma's Cleaners to September 19, 2022.

The three above referenced proposed CAOs order cleanup of discharges of solvent waste.

With very few exceptions, the technical documents referenced in the Lake Tahoe Laundry Works CAO Staff Report were made available to the parties as of the date of the document or are documents that the parties themselves submitted to the Lahontan Water Board. With respect to the remainder (approximately five technical documents and the documents supporting the *United Artists* portion of the Staff Report), Lahontan Water Board staff provided copies to Scott Reisch of Hogan Lovells on June 23, 2022, and received confirmation from William Tarantino of Morrison Foerster, on June 24, 2022, of their access to the provided documents. Consistent with Fox's above request, I am granting an extension of 60 days from the date the additional documents were provided for the proposed CAOs for Lake Tahoe Laundry Works, Big O Tires, and Former Norma's Cleaners. Given the nature and extent of the contamination, we are not inclined to grant further extensions beyond that date.


