Then offer us 50-or so gallons of are water back a day when we pay tax to have 8930 gallons of water a day. Some people lost there land for not paying that tax. Everything they worked for lost to tax laws. Water taxes, land taxes, taxes that pay you to look out for us. Please do your job and give us back the water PG&E has taken from us. The water we paid for. The water the law says is my water to drink, grow crops, beef, pork, fish ponds, swim. Give it back. We will not rest intel you make it right. Stand up to PG&E stop helping them & help us the people that put you there & pay you to be there for us.
