NOTICE OF PUBLIC WORKSHOP

Urban Water Conservation

NOTICE IS HEREBY GIVEN that the State Water Resources Control Board (State Water Board) will hold a public workshop to receive input on potential next steps and future actions related to urban water conservation if drought conditions persist into the new calendar year. This will be an informational workshop only and the State Water Board will take no action.

BACKGROUND

On April 25, 2014, Governor Brown issued an Executive Order calling on the State to redouble its drought actions. Among other things, the Executive Order directed the State Water Board to adopt emergency regulations as it deemed necessary, pursuant to Water Code section 1058.5, to ensure that urban water suppliers implement drought response plans to limit outdoor irrigation and other wasteful water practices. In response to the Executive Order, the State Water Board adopted an <u>Emergency Water Conservation Regulation</u> that went into effect on July 28, 2014.

The Emergency Water Conservation Regulation includes prohibitions on certain water uses and requires urban water suppliers to activate their Water Shortage Contingency Plans to a level where outdoor irrigation restrictions are mandatory. In communities where no water shortage contingency plan exists, the regulation requires that water suppliers either limit outdoor irrigation to twice a week or implement other comparable conservation actions. Urban water suppliers must also report to the State Water Board water use on a monthly basis to track progress.

Data collected by the State Water Board demonstrate that approximately 90 billion gallons of water have been conserved for the period of June-October 2014 as compared to the same period last year. The amount of water conservation realized, however, has been variable throughout the State, as have the types of water conservation measures implemented by individual water suppliers. Additional State and local action to conserve urban water supplies may be needed depending on weather conditions and the water supply outlook.

WORKSHOP OVERVIEW

The purpose of this workshop is to solicit input on a range of additional actions that the State Water Board should consider to compel further urban water savings if drought conditions persist. The workshop will include presentations from invited speakers, followed by public comments and discussion. The State Water Board is interested in receiving public input on the following questions:

- 1. What more should be done at the local and/or State level in the near-term to increase water conservation?
- 2. What additional conservation requirements, if any, should the State Water Board consider adopting if dry conditions persist into the new year?
- 3. What can be done to compel poorer performing areas to increase conservation?
- 4. What additional data should the State Water Board be collecting and how would it be used?

To ensure a productive and efficient workshop, participants with common comments are encouraged to coordinate and provide comments as a group. So that all commenters have an opportunity to participate, presentations and questions may be time-limited.
