REQUIREMENTS FOR THE GARCIA RESIDENCE ALTERNATIVE
ONSITE WASTEWATER TREATMENT SYSTEM, SAN DIEGO COUNTY**

Enclosed are copies of tentative Order No. R9-2009-0007, *Waste Discharge Requirements for the Garcia Residence Alternative Onsite Wastewater Treatment System, San Diego County* and tentative Resolution No. R9-2009-0025, *A Resolution Adopting a Negative Declaration Regarding Potential Environmental Impacts for the Garcia Residence Alternative Onsite Wastewater Treatment System*. The tentative Order, if adopted, will prescribe Waste Discharge Requirements for the discharge of domestic wastewater from an alternative onsite wastewater treatment system located at the Garcia Residence, in the unincorporated area of Encinitas, California. The tentative Resolution will adopt a Negative Declaration of potential environmental impacts from the installation and operation of the alternative onsite wastewater treatment system that would be regulated by the Order. 
