PUBLIC WORKSHOP

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is considering the adoption of Draft Addendum No. 4 to Cleanup and Abatement Order (CAO) No. R9-2004-0258. Draft Addendum No. 4 addresses the cleanup and abatement of wastes discharged to land at the former Teledyne Ryan Aeronautical (TDY) site. A subsequent enforcement Order will be issued to assess and cleanup wastes discharged from landside sources to the marine sediments in Convair Lagoon and San Diego Bay. A site location map is attached.

The San Diego Water Board will hold a public workshop to present an overview of Draft Addendum No. 4 and to provide an opportunity for the public to provide comments.
