

**CALIFORNIA REGIONAL WATER QUALITY CONTROL BOARD

**TENTATIVE ORDER NO. R9-2013-0056**

**AN ORDER RESCINDING ORDERS NOS. 94-07 AND 93-82**

The California Regional Water Quality Control Board, San Diego Region (hereinafter San Diego Water Board), finds that:

1. The following facts support rescission of Order No. 94-07, *Waste Discharge Requirements for Hanson Aggregates Pacific Southwest Region, Otay Plant, San Diego County*.
  - a. Order No. 94-07, adopted by the San Diego Water Board on February 10, 1994, prescribes waste discharge requirements (WDRs) for the discharge of wastes from a sand and gravel processing and concrete batching plant located near the City of Chula Vista in San Diego County. Order No. 94-07 ensures the protection of both surface waters and ground waters via the implementation of best management practices (BMPs) and through monitoring and reporting requirements.
  - b. Hanson Aggregates was also regulated under the State Water Resources Control Board statewide General Industrial Storm Water Permit Order No. 97-03-DWQ (Order No. 97-03-DWQ). On May 16, 2011, Hanson Aggregates submitted a Notice of Termination requesting rescission of Order No. 97-03-DWQ. Hanson Aggregates' coverage under Order No. 97-03-DWQ was terminated by the San Diego Water Board on May 29, 2012.
  - c. Hanson Aggregates requested rescission of Order No. 94-07 via email on August 13, 2012, informing the San Diego Water Board that since March 2008, operations associated with Order No. 94-07 have ceased, and all plant facilities have been removed from the site.
  - d. On November 15, 2012, an inspection of the Hanson Aggregates site confirmed that the facility associated with the processing of sand and gravel and the transit-mix concrete batch plant both no longer exist.
2. The following facts support rescission of Order No. 93-82, *Waste Discharge Requirements for Buena Sanitation District, Shadowridge Water Reclamation Plant, San Diego County*.
  - a. Order No. 93-82, adopted by the San Diego Water Board on September 20, 1993, prescribes WDRs to Buena Sanitation District for the discharge of up to 1.16 million gallons per day of tertiary treated wastewater from the Shadowridge Water Reclamation Plant (Shadowridge WRP). The

reclaimed water from the Shadowridge WRP was used for landscape irrigation by the Carlsbad Municipal Water District and the Vista Irrigation District.

- b. The Buena Sanitation District requested rescission of Order No. 93-82 via letter on February 22, 2012, informing the San Diego Water Board that the Shadowridge WRP was closed on February 2, 2003.
  - c. On March 2, 2006, PG Environmental, LLC – an United States Environmental Protection Agency contractor – conducted an inspection of the Shadowridge WRP on behalf of the San Diego Water Board and confirmed that the plant was no longer in operation.
- 3. The San Diego Water Board has notified all known interested parties of its intent to rescind Orders Nos. 94-07 and 93-82.
  - 4. The San Diego Water Board, in a public hearing, heard and considered all comments pertaining to the proposed rescission.

IT IS HEREBY ORDERED, that Orders Nos. 94-07 and 93-82 are rescinded.
