NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board) is releasing Tentative Order No. R9-2016-0159 (Tentative Order), *An Order Rescinding Order No. 94-127* for public review and comment. The San Diego Water Board will also consider adoption of the Tentative Order at its regularly scheduled meeting on **November 9, 2016**. The Tentative Order, if adopted, would rescind waste discharge requirements in Order No. 94-127, *Waste Discharge Requirements for Mr. William Vander Woude, Valley View Dairy, San Diego County*. The former Valley View Dairy is located in the Ramona Hydrologic Subarea of the Santa Maria Valley Hydrologic Area of the San Dieguito Hydrologic Unit.

Submission of Written Comments

Notice is hereby given that the San Diego Water Board will receive written comments on the aforementioned Tentative Order in accordance with this notice pursuant to Water Code section 13167.5. The submission of written comments is the opportunity for interested persons to raise and comment on issues pertaining to the Tentative Order. Please review and provide any written comments on the Tentative Order **no later than 5:00 p.m. on Tuesday September 29, 2016**. Comments should be submitted electronically to sandiego@waterboards.ca.gov in text searchable Portable Document Format (PDF) or Microsoft Word format. Written comments can also be submitted via regular mail to the San Diego Water Board office at 2375 Northside Drive, San Diego, CA 92108. Please write in the subject line of the email or comment letter "Comment – Tentative Order No. R9-2016-0159, Attn: Roger Mitchell."

The early submission of written comments on the Tentative Order is encouraged. Written comments received by **5:00 p.m. on Tuesday September 29, 2016**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Order. The San Diego Water Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Tuesday September 29**, will

not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.

Public Hearing for Consideration of Tentative Order Adoption

A public hearing on the Tentative Order will be held during the San Diego Water Board meeting scheduled on **November 9, 2016**. The meeting will begin promptly at **9:00 AM** and will be held at the **San Diego Regional Water Board Meeting Room, 2375 Northside Drive, San Diego, California, 92108**.
