NOTICE OF PUBLIC HEARING AND WRITTEN COMMENT PERIOD

The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), is releasing Tentative Addendum No. 2 to Order No. R9-2010-0004, as amended by Order No. R9-2011-0039, *Waste Discharge Requirements for the Las Pulgas Landfill, Marine Corps Base Camp Pendleton, Camp Pendleton, California* (Tentative Addendum), for public review and comment. The San Diego Water Board will consider adoption of the Tentative Addendum at its regularly scheduled meeting on **February 10, 2021**. The Tentative Addendum, if adopted, will modify Order No. R9-2010-0004, *Waste Discharge Requirements for the United State Marine Corps Marine Corps Base Camp Pendleton, Las Pulgas Landfill, San Diego County*.

Submission of Written Comments

Notice is hereby given that the San Diego Water Board will accept written comments regarding the Tentative Addendum in accordance with this notice and pursuant to Water Code section 13167.5.

The written comment period provides an opportunity for interested persons to comment on the Tentative Addendum. All written comments regarding the Tentative Addendum must be received no later than **5:00 p.m. on Monday, January 4, 2021**, to be considered by the San Diego Water Board. Written comments sent by mail must be addressed to California Regional Water Quality Control Board – San Diego Region, 2375 Northside Drive, Suite 100, San Diego, California 92108-2700, and ATTN: Ms. Amy Grove. Comments can also be submitted via e-mail to sandiego@waterboards.ca.gov. The subject line of all written comments must include “Comment – Tentative Addendum No. 2 to Order No. R9-2010-0004.”

Early submission of written comments on the Tentative Addendum is encouraged. Written comments received by **5:00 p.m. on Monday, January 4, 2021**, will be provided to the San Diego Water Board members for their review in advance of the public hearing to consider adoption of the Tentative Addendum. The San Diego Water

Board will prepare written responses to significant comments that are timely received. Consistent with State Water Resources Control Board regulations that apply to this proceeding, written comments received after **5:00 p.m. on Monday, January 4, 2021**, will not be accepted and will not be incorporated into the administrative record if doing so would prejudice any party.
