The California Regional Water Quality Control Board, San Diego Region (San Diego Water Board), released Tentative Order No. R9-2022-0012, *An Order Rescinding Order No. 94-48, Waste Discharge Requirements for SKP Incorporated, SKP Educational Resort of Southern California, Riverside County* (Tentative Order), for public review and comment on January 24, 2022. The Tentative Order, if adopted, will rescind Order No. 94-48, *Waste Discharge Requirements for SKP Incorporated, SKP Educational Resort of Southern California, Riverside County*.
