### **WITHDRAWAL OF ADMINISTRATIVE CIVIL LIABILITY (ACL) COMPLAINT FOR FAILURE TO FILE 2018 SUPPLEMENTAL STATEMENT OF DIVERSION AND USE FOR STATEMENT S003225**

Ms.Wakeham:

On October 18, 2019, the State Water Resources Control Board (State Water Board), Division of Water Rights (Division) provided legal notice to Barbara J. Wakeham of the intent of the Division to proceed with formal enforcement with monetary penalty for failing to file the online Supplemental Statement of Diversion and Use report pursuant to title 23, section 920, of the California Code of Regulations.

Due to extenuating circumstances brought to the Division's attention, the Division is withdrawing the ACL Complaint issued to Barbara J. Wakeham on October 19, 2019. The Division retains its discretion to pursue enforcement for the alleged violation. Nevertheless, the Division agrees to forego any future enforcement regarding the alleged violation if Ms. Wakeham performs the following by July 22, 2020:

1. Update the name and contact information for the primary owner of Statement S003225 in the Electronic Water Rights Information Management System (eWRIMS); and
2. Complete and file the reporting year 2019 Supplemental Statement of Diversion and Use report for Statement S003225.
